

NHDAMF ORGANIC CERTIFICATION and INSPECTION FEES SCHEDULE

Applicants applying for Organic Crop Certification shall pay an **ESTIMATED MINIMUM CERTIFICATION AND INSPECTION FEE OF \$150** per year. An increase in Inspection fees shall apply as indicated in Table 911-1 below:

Applicants applying for Organic Livestock Certification shall pay an **ESTIMATED MINIMUM CERTIFICATION AND INSPECTION FEE OF \$150** per year. An increase in Inspection fees shall apply as indicated in Table 911-2 below:

Inspection fees for livestock shall be determined as indicated below:

To determine the number of animal units (AU) per animal type, use Table 911.3:

Table 911.3 Animal Unit (AU) Equivalent

<u>Animal type</u>	<u>Animal Unit (AU) Factor</u>
Beef Cow	1.00
Dairy Cow	1.40
Swine	0.20
Sheep	0.10
Turkeys and other fowl	0.01
Chickens	0.0025

- An AU shall be calculated by multiplying the number of animals by its respective AU factor, as in the formula below:

$$\# \text{ Animals of each type} \times \text{AU factor} = \text{total number AU's for each animal type}$$

- An AU shall represent 1000 pounds of live animal weight. NOTE: All dairy animals, regardless of age shall be calculated at the 1.4 AU factor.
- An applicant with multiple animal types shall calculate the number of AU per species, then add these figures to get the total number of AU to determine the inspection fee.
