**PRELIMINARY AGREEMENT FOR
PRACTICE RESTRICTIONS**

The New Hampshire Board of Licensed Allied Health Professionals, Respiratory Care Practitioner Governing Board ("Board") first granted Patricia A. Mondro a State of New Hampshire license to practice as a respiratory care practitioner on March 6, 1991. Ms. Mondro holds license number 0189 and practices respiratory care therapy at St. Joseph Hospital located at 172 Kinsley Street, Nashua, NH 03061. Ms. Mondro enters into a Preliminary Agreement with the Board as follows:

1. Recognizing that professional misconduct allegations are now pending against me before the Board, I, Patricia A. Mondro, RCP hereby voluntarily agree to abide by certain restrictions to my license to practice in the State of New Hampshire.
2. I voluntarily agree not to practice as a respiratory care practitioner, and not to treat or see patients in the State of New Hampshire until such time as the Board approves my return to practice.
3. I admit to no violations of RSA328-F: 23, II, RSA 326-E: 8 or any other laws, rules, statutes or regulations.
