**DECISION**

Having received no response from Richard Kalin to the clerk's October 30, 2008 letter and the board's November 18, 2008 Order seeking documentation how he has standing to file an appeal on property titled to Catherine Kalin, the board dismisses the appeal.

A motion for reconsideration of this Decision must be filed within thirty (30) days of the clerk's date below, not the date this order is received. RSA 541:3; Tax 201.37. The reconsideration motion must state with specificity all of the reasons supporting the request. RSA 541:4; Tax 201.37(b). A reconsideration motion is granted only if the moving party establishes the Board's order was erroneous in fact or law. Filing a reconsideration motion is a prerequisite for appealing to the supreme court, and the grounds for appeal will be limited to those stated in the reconsideration motion. RSA 541:6.
