- If a managing agency seeks to grant rights in state lands to Kinder Morgan, the RSA 4:40 process would apply, including review by CORD, the Long Range Planning Committee and approval by Governor and Council
- Properties held in public trust require legislative action to grant property rights to a third party
- Grants of rights in donated properties are subject to review by the Charitable Trusts Unit of the Office of the Attorney General and may require Court approval
