Box 244, Centerville, MA (Docket No: 09-028-EP); and

WHEREAS, appearances were filed in the matter by Steven J. Lauwers, Rath, Young & Pignatelli representing HM Life Insurance Company on April 22, 2009, and by Martha Van Oot and George Roussos, Orr & Reno representing Health Management Advisors, LLC on April 30, 2009; and

WHEREAS, Orr & Reno filed a Motion for Prehearing Conference pursuant to RSA 541-A:31, V (b) and Ins 204.14, dated May 8, 2009; and

WHEREAS, the Department appointed Russell F. Hilliard, Upton & Hatfield as Hearing Officer;  
and

WHEREAS, the Hearing Officer issued an Order on Prehearing Conference dated July 8, 2009;  
and

WHEREAS the Prehearing Conference was held on August 17, 2009 at 9:30 a.m. at the offices of the Department, 21 South Fruit Street, Suite 14, Concord, New Hampshire; now, therefore, be it

ORDERED, that:

1. Department's Counsel shall immediately provide to Respondents' Counsel its preliminary list of witnesses;
2. Respondents' Counsel shall file Motion(s) for Discovery and Response(s) to Department's Motion to Amend Order to Show Cause on or before August 31, 2009;
3. Department's Counsel shall file its response to the Motion(s) for Discovery on or before September 14, 2009;
4. Respondents' Counsel shall file any Motion(s) Regarding ERISA on or before October 5, 2009;
5. All Counsel shall submit witness and exhibit lists to the Hearing Officer and other counsel on or before December 14, 2009;
6. A Pretrial Conference shall be held on December 21, 2009 at 9:30 a.m. at the offices of the Department, at which time counsel shall file Requests for Findings of Fact and Rulings of Law, and any Stipulations; and

7. A Hearing in the matter has been scheduled for the week of January 11, 2010 at the offices of the Department.
