ASSENTED-TO MOTION TO CANCEL HEARING

NOW COMES the Commissioner of Insurance for the State of New Hampshire, by and through its attorneys, the Office of the Attorney General, and, with the assent of Patriot Health Insurance Company, Inc. ("Patriot"), MVP Health Insurance Company of New Hampshire ("MVP"), moves that this Court cancel the hearing scheduled for January 2, 2008, and in support thereof states as follows:

1. On December 11, 2007 the Commissioner filed a Verified Petition for Rehabilitation pursuant to RSA Chapter 402-C requesting that this Court enter a Rehabilitation Order, and a Motion for Expedited Approval of Order Approving Assumption Agreement with MVP Health Insurance Company of New Hampshire, with respect to Patriot Health Insurance Company, Inc.
2. As described in the Commissioner's Verified Petition, and Affidavit in Support of the Motion for Expedited Approval, Patriot's Board of Directors consented to the relief requested therein, and MVP and the New Hampshire Life and Health Insurance Guaranty Association ("NHLHIGA") were involved in the preparation of the same and were fully apprised of the contents thereof.
3. On December 12, 2007 this Court entered the orders described in Paragraph 1 herein, and scheduled a hearing thereon for January 2, 2008.

4. All parties on the Service List have been served with the Orders of Notice in this matter, and Patriot and MVP have assented to the relief requested in this Motion.

5. NHLHIGA has indicated that it does not intend to appear in objection to the Rehabilitation and Assumption Agreement.

6. In light of the foregoing, there is no longer any reason to proceed with the hearing scheduled for January 2, 2008.

WHEREFORE, the Commissioner respectfully requests that this Honorable Court:

- A. Cancel the hearing scheduled for January 2, 2008; and,
- B. Grant such further relief as may be just and proper.
