MOTION REGARDING FILING OF LIQUIDATOR'S REPORTS

Roger A. Sevigny, Insurance Commissioner for the State of New Hampshire (the "Commissioner"), as Liquidator ("Liquidator") of ACA Assurance ("ACA"), hereby moves that the Court enter an order providing that the Liquidator is to file reports with the Court at three month intervals instead of monthly. As reasons therefor, the Liquidator states:

1. Pursuant to RSA 402-C:25, the Liquidator "shall report to the court monthly, or at other intervals specified by the court, on the progress of the liquidation in whatever detail the court orders."
2. As described in the Liquidator's Second Report filed on January 15, 2013, the ACA estate does not have many assets, and the Liquidator does not anticipate a significant level of activity in this liquidation from the present until after the April 22, 2013 claim filing deadline.
3. In light of the limited assets of the estate and the relatively low level of expected activity, the Liquidator submits that it is appropriate to report to the Court at three-month intervals instead of monthly.

WHEREFORE, the Liquidator respectfully requests that this Court:

- A. Grant this Motion to provide for filing of Liquidator's Reports at three month intervals;
- B. Enter an Order in the form submitted herewith approving such Motion; and
- C. Grant such other and further relief as justice may require.




