

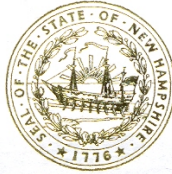

If you do not wish to renew your license, please check the space provided, so that we may update our records. The Board shall charge a late fee of **\$40.00** for each month or fraction of a month the renewal is late, up to 12 months, **in addition to the renewal fee.**
