- A. The petition will not be served (and thus the case will not be scheduled for arraignment) provided there is compliance with the terms of this agreement.
- B. Within \_\_\_\_\_ days, the Juvenile Probation and Parole Officer of Assessment and Diversion will notify the court that the terms of this agreement have or have not been completed to the Juvenile Probation and Parole Officer's satisfaction.
- C. Upon notification to the court of the satisfactory completion of the terms of this agreement, the court will mark the case "WITHDRAWN". There will be no record of a juvenile petition having been filed in this matter.
- D. Upon notification to the court of the unsuccessful compliance with this agreement, the petition will be served and the matter scheduled for arraignment.
