As an alternative to the rates in Appendix D-2, we have provided the following additional cost saving options. These options can be selected in total or on an a la carte basis.

Description	Cost Saving per Case
Option 1: No Pallet/Box Trailers. In RFP Appendix C, Specific Requirements, Item 19, it was requested that the transportation contractor (a) provide the warehouse service of unloading, sorting, reloading and delivering of pallets to warehouse contractor and (b) provide three trailers and the corresponding labor for the accumulation of boxes to be used in the warehouse contractor's operation. If all pallets are returned directly to the Bow Warehouse rather than accumulating in Nashua and if we did not have to bear the cost of the box trailers, we can eliminate this cost from the NHSLC's rates.	\$0.015 (\$300,000 savings)
Option 2: No removal of equipment on Friday. In the April 12 th Amendment to the RFP, it was stated that all equipment would need to be removed from the warehouse contractor's site on Friday evening and returned on Sunday evening. If trailers can remain staged at the warehouse over the weekend, we can reduce this additional cost from the NHSLC's rates.	\$0.02 (\$400,000 savings)
Option 3: No electronic signature. If the electronic delivery receipt/signature is waived, the cost of the hardware, software and monthly maintenance fees can be eliminated from the NHSLC's rates.	\$0.005 (\$100,000 savings)
Option 4: Increased load factors. As discussed in Section 2.6, reduced load factors have negatively impacted pricing to the NHSLC. If load factors can be improved to current levels, we can reduce this additional cost from the NHSLC rates.	\$0.01 (\$200,000 savings)

If all savings options are utilized, the Rate per Case can be reduced by \$0.05 (approximately \$1,000,000). The final rates with these reductions are shown on the next page.
