LICENSEE MARK HAYES ATTENDED THE MEETING; HE STATED THAT HE HAS BEEN LICENSED SINCE 2007; HE IS OPEN FOR BUSINESS THURSDAY THROUGH SUNDAY IN THE SPRING; STARTING IN JUNE, HE IS OPEN 7 DAYS A WEEK; HE CLOSED HIS BUSINESS AFTER THE LAST EVENT OF THE YEAR – A FUND RAISER – HELD ON 11/15/14 AND HE WAS NOT OPEN IN DECEMBER, 2014; HE WOULD RATHER APPEAR BEFORE THE COMMISSION WITH REGARD TO THE PENALTIES THAN HAVE SOMEONE SERIOUSLY INJURED; HE MADE A MISTAKE ON 11/15/14; HE HIRED A SECURITY COMPANY THAT HE HAD USED IN THE PAST; THEY DID NOT TELL HIM THERE WERE ISSUES WHEN THEY WERE HAPPENING; DIRECTOR WILSON SAID THE DATE OF VIOLATION WAS 11/15/14 AND THAT THE SUSPENSION WILL OCCUR AROUND THE SAME TIME OF YEAR AS THE DATE OF VIOLATION; THE LICENSEE’S ATTORNEY REQUESTED LENIENCY; THE LICENSEE WAS OFFERED LOWER FINES FOR AN EARLIER SUSPENSION BUT HE DECLINED; DEPUTY COMMISSIONER MILLIGAN STATED THAT HE WILL ACCEPT THESE NEGOTIATED PENALTIES BUT ONLY BECAUSE THE LICENSEE HAS HELD A LICENSE SINCE 2007 AND BECAUSE HE HAS NO VIOLATION HISTORY; OTHERWISE, HE WOULD CONSIDER A YEAR-LONG SUSPENSION GIVEN THE CIRCUMSTANCES; THE VIOLATIONS THAT OCCURRED MUST NOT HAPPEN AGAIN BECAUSE THEY RISE TO THE LEVEL OF A PUBLIC SAFETY ISSUE; AS THE LICENSEE, IT IS HIS RESPONSIBILITY TO KNOW WHAT IS HAPPENING ON HIS PREMISE; PERHAPS THEY SHOULD AVOID HOLDING AN “END OF YEAR” EVENT; THE COMMISSION IS REGULATORY AS WELL AS EDUCATIONAL AND THE LICENSEE SHOULD AVAIL HIMSELF OF THEIR ASSISTANCE IN TERMS OF EDUCATION AND TRAINING; THE COMMISSION WANTS THE LICENSEE TO CONTINUE HOLDING A LIQUOR LICENSE; HOWEVER, PUBLIC SAFETY MUST BE UPHELD.
