A Hearing was held on October 24, 2023: Decision dated 11/03/2023:

“Following due consideration of the evidence and the recommended penalty, the presiding officer finds that the assessment of 4 points on the license are appropriate and orders that they be imposed. As to the other terms of the recommended penalty, the presiding officer notes, as did Investigator Patterson at the hearing, that the standard base penalty for a violation of RSA 179:5 in N.H. Code Admin. Rules Liq 603.01(a)(7) includes a \$500 fine and a three-day suspension. The presiding officer, however, does not find a suspension warranted in these circumstances, given the licensee’s history and attempts to mitigate negative consequences from service to the intoxicated individual here. Neither does the presiding officer find that a suspension should be entirely excused. Accordingly, pursuant to the discretion to impose an appropriate penalty considering all circumstances granted by N.H. Code Admin. Rules Liq 603.02, N.H. Code Admin. Rules Liq 603.03, and RSA 179:57, the presiding officer imposes the following penalty in addition to the points noted above: the licensee is fined \$500, payable within 5 days of this order consistent with N.H. Code Admin. Rules Liq 604.01; and a suspension of alcohol service for three days is held in abeyance for 12 months pending no similar violations occurring. For clarity, the licensee is not suspended at this time, but if a new violation occurs within 12 months of the date of this order, the three-day suspension described in this order shall be imposed in addition to any suspension or other penalty that may result from that new violation.

Lastly, the presiding officer understands from Mr. Stevens that the licensee’s business may be sold in the near future. The suspension described in this order shall, to the extent the law permits, remain with the licensed business in the event of such sale.

Consistent with N.H. Code Admin. Rules Liq 206.04, any party may petition for a rehearing within 30 calendar days of being notified of this decision.”
