A little history . . .

1965 NH Legislature established an **Arts Commission**.

1966 National Endowment for the Arts, a federal agency, awarded our first “seed grant” of \$25,000.

1985 **Arts Commission** was merged into a new Department of Cultural Resources.



NH's public investment in culture is provided through the Department of Cultural Resources

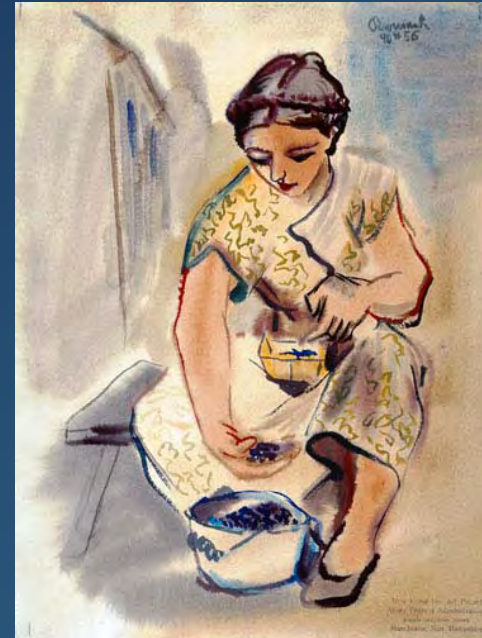

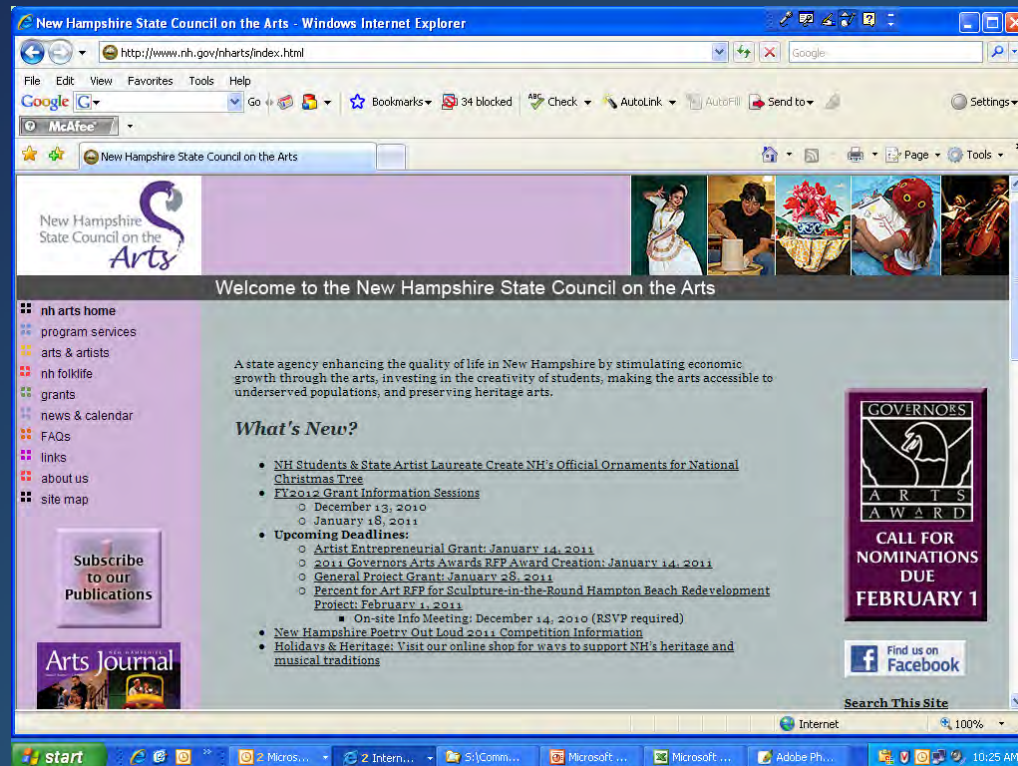

FY2013 Grants for Organizations

State Fiscal year = July 1, 2012 to June 30, 2013

Most projects fall within the fiscal year.

Some categories extend to Sept 30, 2013

Operating Grants

Historically: Up to \$15,000 per year

Awarded in **two-year cycles**

Next deadline: spring 2013 for 2014/2015

Investment in the cultural infrastructure.

Funding supports administration needs of **arts organizations**.

- ❖ Match Requirement: 10:1 cash match
- ❖ FY2013 Operating grantees **may apply** for **5** other grant categories:
 - ❖ Cultural Facilities Grants
 - ❖ Conservation License Plate Grants
 - ❖ Youth Arts Project Grants
 - ❖ Traditional Arts focus of the General Project Grant
 - ❖ Arts in Health Care Project Grants



Cultural Facilities Grants

Barrier Free Access for All

\$1,000 - \$8,000

Deadline: April 27, 2012

To support improvements to cultural facilities that broaden access for people with disabilities.

- ❖ Match Requirement: 1:1
In FY2013 ½ match may be in-kind goods and services
- ❖ FY2013 Operating Grantees may apply!



Conservation License Plate Grants

\$2,000 - \$20,000

Deadline: April 27, 2012



Supports conservation of publicly owned cultural facilities, documents and/or artworks

- ❖ No match required!
- ❖ FY2013 Operating Grantees may apply!

Funds are generated from the sale of “Moose license plates”

General Project Grants

\$750 - \$4,500

Deadline: August 3, 2012

(For projects: Nov 1, 2012 to Sept 30, 2013)

- ❖ Match Requirement: 1:1
In FY2013 ½ match may be in-kind goods and services
- ❖ Traditional Arts Project Grants are enfolded in this category. Special narrative questions address this focus!
- ❖ FY2013 Operating Grantees may apply for Traditional Arts focus!

Artist Residencies in Schools Grants

\$1,000 - \$4,500

Deadline: March 2, 2012

Support artist residencies in schools and alternate education sites to engage students in high quality arts learning.

❖ Match Requirement: 1:1
Cash match can include
pro-rated staff salary!
For FY2013 ½ of match may
be in-kind goods and services!

Youth Arts Project Grants

for Extended Learning

\$1,000 - \$4,500

Deadline: April 6, 2012

- ❖ To support high quality arts learning experiences for youth outside of the normal school day.
- ❖ Match Requirement: 1:1 Cash match can include prorated staff salary! For FY2013 ½ of match may be in-kind goods and services!
- ❖ FY2013 Operating Grantees may apply!



Arts in Health Care Grants

\$1,000 - \$4,500

Deadline: May 4, 2012

Supports bringing trained artists into health care, nursing homes and rehabilitation facilities to improve the health and lives of patients & residents.

- ❖ Match Requirement: 1:1 - For FY2013 ½ of match may be in-kind goods and services
- ❖ AIH Directory has info on artists trained to work in health care settings.
- ❖ FY2013 Operating Grantees may apply!

Eligibility Criteria for Arts Orgs & Arts Partners (schools, etc)

- ❖ Incorporated in **New Hampshire** as a non profit and with the IRS as a 501(c)3 (except schools & municipalities)
- ❖ In **Good Standing** with the State of NH Secretary of State's office & Attorney General's office (except schools & municipalities)
- ❖ In compliance with **required reports** from past NHSCA grants (all applicants)
- ❖ Programming must occur in facilities that are in compliance with the **Americans with Disability Act** (ADA) (all applicants)

Artist Entrepreneurial Grants

\$250 to \$1,000

FY2013 – Deadline TBA

Business & skills development for professional artists.

- ❖ Professional Artist = people who devote a majority of time to practicing, performing, and/or teaching an arts discipline and who receive payment for their work in that discipline.
- ❖ In FY 2013, no declared match is required as grant amount generally reflects a small portion of cost for professional development.

Individual Artist Fellowships

Two @ \$4,000

Deadline: TBA

To recognize and honor
artistic excellence &
commitment

- ❖ FY2013 Focus: Performing Arts
- ❖ If awarded a Fellowship, community engagement activities are required & represent match.
- ❖ Artists receiving 3 Fellowships are designated “Lifetime Fellows.”

Traditional Arts Apprenticeship Grants

Up to \$3,400 per team

Deadline: June 22, 2012

(Projects: Nov 1, 2012 to Sept 30, 2013)

Support the preservation of traditional crafts, dance & music.

- ❖ Funds a master traditional artist to teach an experienced apprentice in one-to-one sessions.
- ❖ Applicants apply as a team.
- ❖ Funds support master artist fees & supplies and transportation (no apprentice stipend!)
- ❖ If awarded an Apprenticeship, a required community presentation represents match.

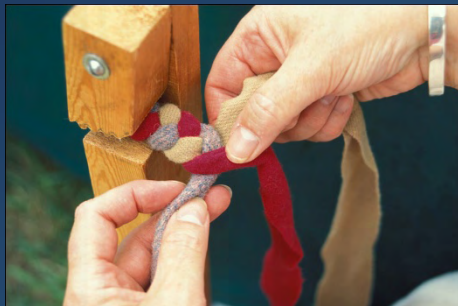

What are traditional arts?

- ❖ Artistic activities that are passed on from **generation to generation** within families and communities and cultural groups.
- ❖ The **aesthetics** are shaped more by the **community** from which the tradition emerged than by personal artistic vision.



IMPORTANT:

All grant categories & amounts
are subject to
change,
as they are dependent upon
availability of state and
federal funds.



How is an application reviewed?

The peer panel review process:

- ❖ Staff reviews for eligibility & completeness
- ❖ Panel drawn from community members reviews applications based upon published criteria
- ❖ Arts Councilors review & approve panel recommendations
- ❖ Grants to orgs over \$5,000 & individuals over \$2,500 go to Governor & Executive Council approval

Processing begins & takes time, so . . .
plan your cash flow accordingly!



Grants Basics

Helpful Info

- ❖ **Send us a draft! Call with questions!**
- ❖ **Check your match!**
- ❖ **Make sure your narrative is concise**
- ❖ **Be sure to address education component & method of evaluation**
- ❖ **Understand your responsibilities as a grantee**



Reporting Requirements

- ❖ Final reports are due 30 days after the project end date or no later than July 31 for projects ending by June 30 and no later than October 31 for projects ending by Sept 30.
- ❖ **Extensions** of up to 3 months may be given. Requests must be submitted in writing before the final report deadline.
- ❖ Failure to submit report or extension = **ineligible to apply** for two years!



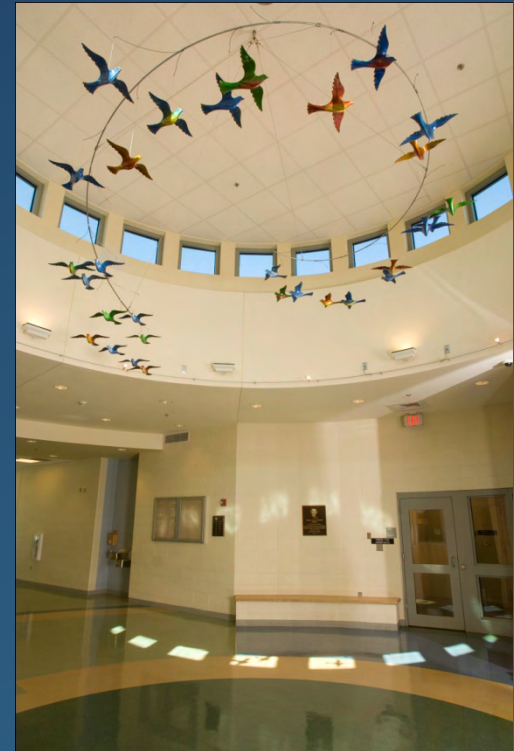

Percent for Art: Acquisitions of artwork for State Buildings

- ❖ The Percent for Art program adds $\frac{1}{2}$ of 1% of cost of major construction & renovations of state funded buildings for public art.
- ❖ Requests for Proposals (RFPs) are issued as projects come up.

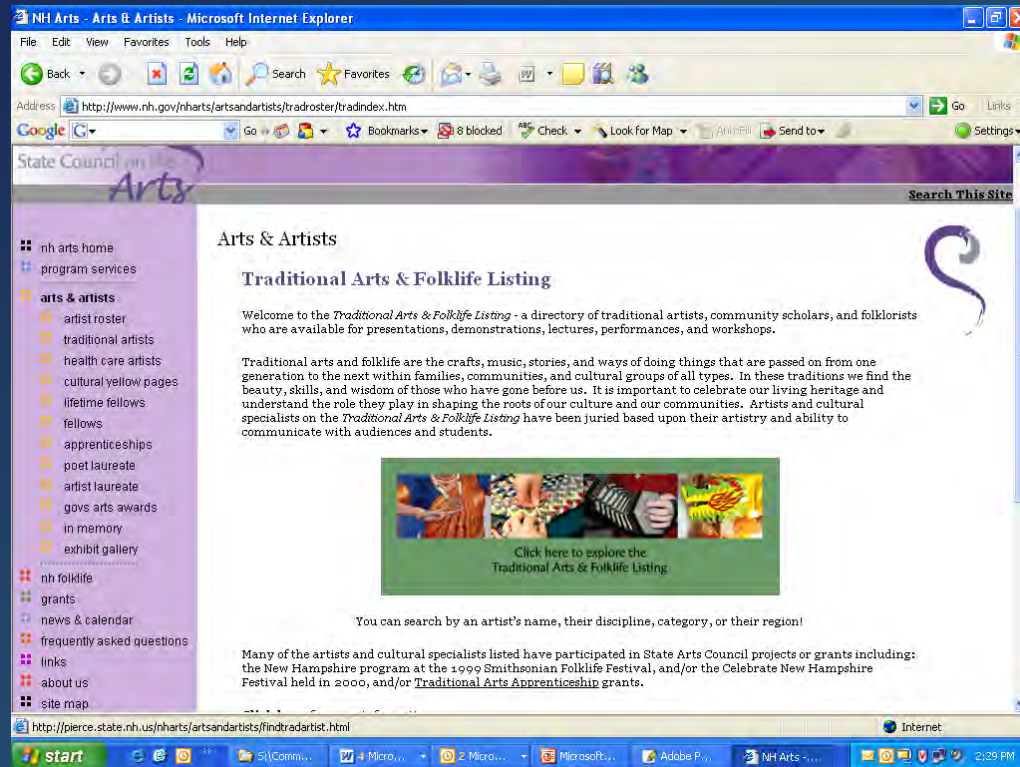

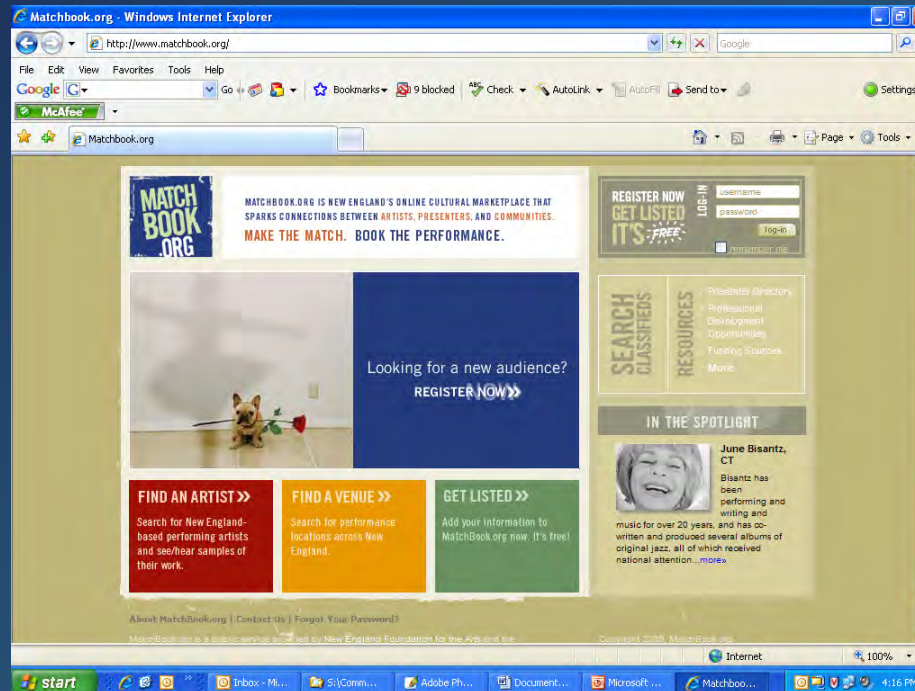
