

RENEWAL-RECERTIFICATION TRAINING FOR 2009 (MAY-DECEMBER)

Enrollment in the **1-hour RECERTIFICATION TRAINING** is restricted to a current certified volunteer who has attended NH DOC Orientation within the previous 36 month. Recertifying volunteer may also attend a standard 2-hour Orientation for scheduling convenience; a separate Orientation Schedule is available. Participation in required training at any location will be accepted at all other NH Department of Corrections facilities. Approved application and documented recertification training are only considered **valid** for a **3-year** period. Recertification, including application and attendance at training, will then again be required. Please COMPLETE the RECERTIFICATION TRAINING ENROLMENT FORM and SUBMIT AT LEAST ONE (1) WEEK PRIOR TO YOUR PREFERRED SESSION; unscheduled walk-ins will not be accommodated. To comply with prison security protocol, enrollment closes 7 days before each session.
