Ratification of a 2 Year Extension of the Public Works Collective Bargaining Agreement.

Pamela Brenner, Town Administrator, Town of Peterborough, and Kevin Foley, Business Agent, Teamster Local 633 of NH, are pleased to announce a 2 year extension, July 2011 to June 2013, to the present Collective Bargaining Agreement between the Town and the Department of Public Works Employees. Both parties clearly recognizing today's economic climate worked diligently to cooperate, ultimately agreeing to only a minor language change in the agreement. The language change brings the agreement in to closer alignment with the vacation benefit of non-union employees and does not require any additional appropriation. There are no other changes to the agreement.

The Town Administrator continued by stating; "That all the Public Works Employees are commended for their outstanding work ethic, their team approach and their professionalism. They stepped up by acknowledging the economic conditions our taxpayers are facing and their actions show that they are part of the solution and a class act."



Article XIV Vacation Leave


