
MOTION FOR REHEARING

The Board, meeting at its offices in Concord, New Hampshire, on September 2, 1993, took the following actions:

1. It examined the unfair labor practice (ULP) complainants filed by Hampton Fire Officers on January 5, 1993; by the Hampton Firefighters on January 21, 1993; by the Hampton Police Association on January 27, 1993; and by the State Employees Association on December 1, 1992 as well as the Town's respective answers thereto.
2. It reviewed its decision (Decision No. 93-93) in this matter dated July 16, 1993.
3. It DENIED the Town's Motion for Rehearing filed August 3, 1993 and opposed by the various Associations' respective filings on August 17, 1993 (SEA) and August 18, 1993 (others).
