The NEPBA filed the certification and modification petitions seeking to create five new bargaining units comprised of positions in the Department of Corrections and the Liquor Commission and to obtain an election to determine representation of employees in the proposed bargaining units. All of the involved positions were in bargaining units represented by the SEA. The SEA objected to any election proceedings claiming that a collective bargaining agreement was in place at the time the petitions were filed and that, accordingly, the petitions should be dismissed.

The PELRB found that the petitions were filed after the expiration of the most recent collective bargaining agreement between the SEA and the State and that, therefore, the SEA's objection that the NEPBA election petitions are barred by RSA 273-A:11 (b) was without merit. The PELRB also rejected the SEA's argument that the proliferation of bargaining units would create inefficiency in government operations. The PELRB ordered the issuance of the Order of Election.
