MODIFICATION OF CERTIFIED BARGAINING UNIT

A representation proceeding having been previously conducted by the Public Employee Labor Relations Board in accordance with RSA 273-A, and the Rules and Regulations of the Board, which resulted in the selection of an exclusive representative, and where, in accordance with PELRB Decision No. 2010-006, it has now been determined that a modification of the certified bargaining unit's composition is appropriate under the provisions of RSA 273-A; then,

Pursuant to the authority vested in the Board by the Public Employee Labor Relations Act, IT IS HEREBY CERTIFIED that the Teamsters Local 633 of New Hampshire is the exclusive representative of the employees of the above named public employer, in the unit as described below, for purposes of collective negotiations and settlement of grievances.

UNIT: All Directors and Coordinators employed by the City of Manchester School District, SAU 37 in the following positions - Attendance Coordinator, Director of School Food & Nutrition Services, Senior Accountant, Assistant Director of Student Services, Special Education Coordinator, Transportation Coordinator, IT Help Desk Coordinator, Athletic Director, District Grant Writer, Fine Arts Director, Medicaid Coordinator, School/Community Service Coordinator, Court Liaison, Federal Projects Director, Director of Alternative Education, Coordinator of the Deaf & Hard of Hearing, Facilitator of Project Lead the Way, Parent-Involvement Coordinator, Supervisor of Pass Program, Data Analyst, Supervisor of Alternative High School Program.

EXCLUDED: 21st Century Director, Accounting Manager, Assistant Superintendents, Superintendent, Benefits Coordinator, Assistant Business Administrator, Human Resources Coordinator, Director of Information Technology, Payroll Supervisor, Human Resource Director, Chief Financial Officer.

Further, IT IS ORDERED that the above named public employer shall negotiate collectively with the exclusive representative named herein for wages, terms and conditions of employment for the members of the bargaining unit, as herein described, and shall recognize the right of such exclusive representative to represent employees in the settlement of grievances.
