**Modification of Certified Bargaining Unit**

Pursuant to RSA 273-A and PELRB Decision No. 2017-190 granting the Union's petition for modification, the existing certification, set forth in PELRB Decision No. 2015-154 (July 2, 2015), is amended; and it is hereby ordered that the composition of the modified bargaining unit, represented by the Pittsfield Town Employees, AFT #6214, AFT-NH, AFL-CIO for purposes of collective negotiations and settlement of grievances, is as follows:
