VOLUNTARY SURRENDER OF LICENSE

Recognizing that professional misconduct allegations are now pending against me before the New Hampshire Board of Registration in Podiatry ("Board") concerning billing practices and a surgical procedure that resulted in a bone infection, I, G. Stephen Minaudo, D.P.M., hereby voluntarily surrender my New Hampshire license (#143) effective on the date that the Board accepts this offer of voluntary surrender.

By voluntarily surrendering my license, I understand that:

1. I relinquish all rights and privileges to practice podiatry in the State of New Hampshire effective upon the Board's acceptance of this voluntary surrender.
 2. I admit that this license surrender has occurred in settlement of pending disciplinary charges.
 3. I admit to no violations of RSA 315:9, but recognize that the Board will consider this voluntary surrender as a disciplinary action.
 4. Should I again seek licensure in the State of New Hampshire, I must meet and shall bear the burden of proving compliance with all of the standards and prerequisites then required by the Board for new applicants, including professional character requirements.

5. I understand that the pending disciplinary allegations shall be resolved in any future license application I may submit in New Hampshire. I hereby specifically waive any statute of limitations or laches defense that might then be available as to these misconduct allegations.

I understand that if the Board chooses to accept my surrender of license, this document shall be distributed to any relevant licensing authorities and professional societies in the same manner as a final decision making specific finding of professional misconduct. I recognize that the Board will treat this voluntary surrender as a disciplinary action. I understand that this document shall become a permanent part of my file and will be maintained by the Board as a public document.
7. I voluntarily submit this surrender of license to the Board and state that no promises or representations have been made to me other than those terms and conditions expressly stated herein.
