**IMPORTANT:** YOU MAY BE ELIGIBLE FOR AN AUTOMATIC 7-MONTH EXTENSION OF TIME TO FILE YOUR NEW HAMPSHIRE BUSINESS ENTERPRISE TAX AND BUSINESS PROFITS TAX RETURNS WITHOUT FILING AN APPLICATION.

<b>HOW TO QUALIFY FOR AUTOMATIC EXTENSION</b>	<b>If you pay 100% of the Business Enterprise Tax and Business Profits Tax determined to be due, by the due date of the tax then you will be granted an automatic 7-month extension to file your New Hampshire returns WITHOUT filing this form.</b> If you meet this requirement, you may file your New Hampshire Business Enterprise Tax and Business Profits Tax return up to 7 months beyond the original due date and you will not be subject to the late filing penalty. <b>Please note that an extension of time to file your returns is not an extension of time to pay the tax.</b>  If you need to make an additional payment in order to have paid 100% of the tax determined to be due, then you must submit this form with payment by the original due date in order to be granted an extension of time to file your returns.
<b>WHEN TO FILE</b>	This form must be postmarked on or before the original due date of the returns.
<b>REASONS FOR DENIAL</b>	Applications for extension will be rejected for reasons such as, but not limited to, failure to complete the tax payment schedule, absence of the taxpayer's or authorized agent's signature, the application was postmarked <b>after</b> the due date for filing the return, or if the payment for the balance due shown on line 5 below did not accompany this application.
