### 1) Welcome/Membership

# 3) Division/Committee Reports

# a) Division/ Bureau of EMS

- i) Assistant Director Jeff Phillips reviewed open positions at the Division, including a PT compliance investigator, PT ambulance inspector, and program coordinator.
- ii) DHHS has secured an additional \$407,000 for an expansion of continuum, specialty services and critical care training programs.
- iii) One year is left of the fully funded EMR training program.
- iv) A Law Enforcement, Professional Firefighter and EMT Career Development funding program for members of these professions to take community college classes at no cost, as well as reimbursement for training programs completed at the Division.
- v) Canine Protocol hearing set for December 13<sup>th</sup>, the 21<sup>st</sup> of December the CB will be making a vote to send it to the Commissioner.
- vi) The ETA rules public hearing was held on October 23, 2023 and the Division received good feedback.

- vii) The Division is tracking several LSR's that relate to Fire and EMS services, but the official language for the bill has not been released.
- viii) January 17<sup>th</sup> and 18<sup>th</sup> the Division will be hosting a Mental Health Seminar.
- ix) There are 38 open EMS investigations taking place.

a) TMRC met in October, has made the prehospital subcommittee an ad hoc committee and discussed hospital designation changes to level 4 hospitals.

# Sedation for Invasive Airway

• This protocol was approved in May 2022, but was sent back to have the dosing align with the RSI protocol, clean up some grammar and and adjusted pediatric fentanyl dose.

# <u>Musculoskeletal</u>

- Added patella reduction at the Paramedic level.
- Hubble made a motion to move it to the AEMT level, Nathan 2<sup>nd</sup> and the motion passed.

Changed Norepinephrine infusion rate in adults to Norepinephrine Infusion 1–80 microgram/minute via pump. Starting dose 1-15 microgram/minute, titrate 2–5 microgram/minute every 5 minutes, as needed in the following:

- Bradycardia
- Post Resuscitation
- Sepsis
- Non-Traumatic Shock
- Cardiogenic Shock

# <u>Pain</u>

- Changed the IV acetaminophen dose from "over 10 minutes" to "over approximately 10 minutes".
