IV. Division / Committee Reports

3) Bureau of EMS and Division Updates – Chief Justin Romanello

- a. The FROST program is optional for any 1st responder agency. This testing occurs once a month. So far, 60 primary departments are participating. This was launched on November 9th.
- b. 93 electrostatic sprayers have been given out to transport departments. The next delivery will go out to the remainder of transport services and then non-transport services.
- c. Actively working on the vaccination planning with HSEM and DHHS. 13,500 first responders to vaccinate. EMS will only assist by acting as a vaccinator if you are an AEMT or Paramedic.
- d. Complacency with PPE usage is a protocol violation. Please address any complacency issues that you see. The Division will help if the local level needs assistance.
- e. Dr. Scollan and others have been reviewing the current Emergency Protocols. The Chair and Vice Chair of both the MCB & CB will be included in the updates made.
- f. November 1st was the deadline to complete Protocol Rollout 8.0. A little over 1,000 providers have yet to complete 8.0. Emails have gone out to encourage the completion of this Protocol Rollout.
- g. As of the 30th of September, 34 EMR's were deactivated, leaving approximately 180 EMR's in the State.
- h. The Division is transitioning internally to the User Management System soon, then the public will be introduced to it around 1 year of internal staff using it.

Dr. Seefeld asked if any other members are having issues with the reusable N95 mask, as far as EMS coming in wearing them or utilizing them. A comment was made about the exhalation port on these masks needed to be covered. Some hospitals are buying the cover for this port or using a surgical mask over it. Chief Romanello stated that addressing this at the local level would be ideal.

V. Protocols

a. Pain Dose Ketamine for Transcutaneous Pacing

Chair Rix was looking for thoughts on the painful procedure involved in transcutaneous pacing and potentially using analgesia instead of sedation and using critical thinking when needed .Dr. Suozzi agreed. Chief Romanello also mentioned the appropriate necessity of encouraging providers to critically think. Chari Rix mentioned that some ALS providers are interpreting in the cardiac arrest algorithm "consider epinephrine" as a take it or leave it option. Put there to allow Paramedics to assess the appropriate needs based on the clinical situation. Scenario type teaching has a huge benefit to get providers thinking critically

A brief discussion ensued about how the protocols are interpreted based on the language used.

VI. Old Business

a. Maximum Quantities of Controlled Substances

The Board was questioning whether changing the maximum quantity would need to filter through the Board of Pharmacy or not. Nobody thought the amount of Fentanyl wasn't enough, but a potential issue could occur on a busy holiday weekend where more Fentanyl could be needed. Chief Romanello mentioned the Board could vote on it and then the Bureau could check on it with the Board of Pharmacy.

b. "Just Culture"

A subcommittee met that included Dr. Rix, Dr. Suozzi and Dr. Freese. They discussed potential language changes regarding the revocation of a license for an actionable complaint wording. The word "shall" was of discussion. Chief Nick Mercuri explained that the law states what the Commissioner can do and the rules are how it gets implemented. Chief Mercuri discussed this with a Department of Safety Attorney and a Senator. Chief Mercuri stated that the word "shall" was carefully chosen for multiple scenarios. Chief Mercuri confirmed that we cannot change the word "shall" to "may" in the rules because it would conflict with the law. The ability to change this rule is unavailable without a law change (153-A:13.) If the word "may" is used, the determination of when it will be used and when it will not be used has to be stated. The objective is to focus on when there is a clear violation seen, documentation can be noted. Then, if a pattern is recognized, the ability to look back on the violation is there. When the time comes to talk with the legislature, having that support in person or in a letter. This discussion will also be talked about in the Coordinating Board.

VII. New Business

Language Changes for License and Notification of an Actionable Complaint
 Discussion occurred under Old Business, "Just Culture." Motion made under New Business.

Chair Rix explained that the sub-committee also discussed notification of an actionable complaint. When a complaint is filed or if the Bureau seeks immediate suspension or if the Director determines the provider is a potential threat to public health or safety, nowhere is it stated that the Medical Director or MRH is informed. The MCB had discussed adding the step of informing the Medical Director. Coordinating Board Chair Jeremy LaPlante stated his concern with employer/employee relationship. Dr. Trimarco mentioned physicians in medicine are required to notify any potential employer or hospital that is going to credential them to work in that hospital if any action has been taken against their license at any point, including any claims or investigations whether they became truthful or not. Chief Nick Mercuri confirmed that at times, complaints are filed against providers and or investigations are started and Medical Directors are not always brought in as part of the complaint process depending on the facts of the case.

They prorated our State to \$17,500 and the bigger states a little over \$20,000. An update will be provided to the Board in January.
