America's PrepareAthon! Day of Action - April 30, 2016

HSEM asks individuals, families and organizations in New Hampshire to participate in America's PrepareAthon! Day of Action on April 30 by completing one step toward their all-hazards preparedness: 1) Sign up for NH Alerts; 2) Make a Family Emergency Plan; 3) Build an Emergency Kit; and 4) Complete Emergency Contact Cards. HSEM's emergency preparedness website, www.ReadyNH.gov, provides links, guides, promotional materials and information about hazards in New Hampshire.

HSEM's goal is to build a more resilient state by educating the public about disasters that could happen in New Hampshire and the all-hazards approach to preparedness, that is, the core steps all people and organizations can take to stay safe during any disaster. Individuals and organizations can participate by completing at least one step in their all-hazards preparedness.

The Federal Emergency Management Agency (FEMA) has established Saturday, April 30, 2016 as the fifth national America's PrepareAthon! Day of Action. The Day of Action is meant as a call to action for both organizations and individuals to take steps to prepare for future disasters. Held every spring and fall, the program is designed to increase the understanding of hazards most relevant to local communities and to educate the public on mitigation and protective measures they can take before an emergency occurs.

An Alert Public is Critical to Keeping Our Nation Safe

The U.S. Department of Homeland Security's "If You See Something, Say Something™" (S4) campaign is a simple and effective program that raises public awareness for indicators of terrorism and terrorism-related crime and emphasizes the importance of reporting suspicious activity to the proper local law enforcement authorities.

An important part of the S4 campaign is the Nationwide Suspicious Activity Reports Initiative and the critical role that the public performs in reporting suspicious activity. Suspicious activities are behaviors and indicators that, when viewed in the totality of the circumstances, may reasonably indicate terrorism-related criminal activity. First Amendment activities should not be reported as suspicious activity, unless the facts and circumstances supporting the behavior observed are reasonably indicative of criminal activity associated with terrorism. Race, ethnicity, national origin or religious affiliation should not be considered as factors that create suspicion.

- Testing of Security
- Recruiting

- Breach/Attempted Intrusion
- Misrepresentation
- Sabotage/Tampering/Vandalism
- Cyberattack
- Expressed or Implied Threat

Online Suspicious Activity Report (SAR) Training Offered

The Nationwide Suspicious Activity Report Initiative (NSI) is designed to increase the effectiveness of state, local and tribal law enforcement and public safety professionals and other frontline partners in identifying, reporting, evaluating and sharing pre-incident terrorism indicators to prevent acts of terrorism.

To increase the effectiveness of this multifaceted approach, the NSI has developed training programs for frontline officers and hometown security partners regarding documented and verified behaviors and indicators that, when viewed in the totality of circumstances, may indicate terrorism-related criminal activity.

Both the SAR Line Officer Training and the sec-

tor-specific SAR Hometown Security Partners Training discuss how to report identified suspicious activity to the proper authorities while protecting privacy, civil rights and civil liberties. Suspicious Activity Reporting Training is available at http://nsi.ncirc.gov/training_online.aspx for:

Drug Monitoring Initiative (DMI) Supports Community Leaders, Decision Makers

The New Hampshire Drug Monitoring Initiative (DMI) is a holistic strategy designed to provide awareness and combat drug distribution and abuse. The DMI

obtains data from various sources, including public health, law enforcement and emergency medical services, and provides monthly products for stakeholders



as well as situational awareness releases as needed.

This initiative directly supports community leaders and decision makers by establishing an intelligence capacity that enables public safety and public health experts to better understand trends, implications and threats from illicit drug activity.

The New Hampshire DMI contributes to combating New Hampshire's heroin problem by serving as a centralized hub for data collection, analysis and information sharing. The DMI is responsible for data collection and analysis aimed at providing a more comprehensive statewide picture of the heroin problem and information sharing to all stakeholders, including public safety officials, public health experts, policy and

decision makers. This includes sharing information within New Hampshire, regionally and nationally to stay ahead of trends occurring in other regions.

The New Hampshire DMI Monthly Unclassified bulletin includes statistics and trends related to opioid related emergency admissions, heroin and prescription opiate treatment admissions, EMS Narcan administration and drug overdose deaths, as well as other drug related situational awareness items.

Seabrook Station Evaluated Exercise

On April 5, the State of New Hampshire participated in the final, evaluated exercise of the 2016 Seabrook Station Exercise Cycle, completing the exercise cycle that started in September 2015. Private, local, state and federal partners and Seabrook Station staff participated. Every two years, each nuclear power plant in the United States is required to conduct radiological emergency preparedness exercises, which involve the surrounding states.

Seabrook Station is one nuclear power unit that generates 1,244 million watts of electricity—enough to power the annual needs of 1.2 million families. The 10 mile radius around Seabrook Station is referred to as the Emergency Planning Zone (EPZ) and in New Hampshire, encompasses 17 towns, all in Rockingham County; including Brentwood, East Kingston, Exeter, Greenland, Hampton, Hampton Falls, Kensington, Kingston, New Castle, Newfields, Newton, North

Hampton, Portsmouth, Rye, Seabrook, South Hampton and Stratham. There are also six Massachusetts towns in the Seabrook EPZ. The three host communities, Dover, Rochester and Manchester, also participated.

During the evaluated exercise, representatives from the Federal Emergency Management Agency (FEMA) Radiological Emergency Preparedness (REP) program evaluate the performance of the State of New Hampshire and local communities for their compliance to REP evaluation criteria. This is to ensure that the entire Offsite Response Organization maintains capacity and capability to respond to an incident at a nuclear power plant and protect public health and safety.

HSEM Implements New Radiological Equipment

The Radiological Instrumentation Maintenance and Calibration (RIMC) shop is implementing new radiological equipment for Emergency Operations Centers in the Seabrook Station Emergency Planning Zone. The new equipment, Radiation Monitoring Devices Model Radalert 100X from International Medcom, Inc., will be used for monitoring background radiation. The

devices are more user-friendly than the current analog survey meters. RIMC staff hope to have the new equipment deployed by July 1, 2016.

What is WebEOC?

The WebEOC Program is the database software that the State of New Hampshire Homeland Security and Emergency Management (HSEM) uses as the state's crisis management software. WebEOC is currently used by 48 states, the federal government and a variety of private entities. WebEOC allows for the ability to interface with other WebEOC users for information sharing purposes, although each organization may utilize WebEOC differently.

Within the State of New Hampshire, WebEOC has multiple uses. Its primary purpose is to provide situational awareness, as well as assist with disaster management during critical incidents in the state. During an incident, WebEOC's main purpose is to provide community leaders, first responders and decision makers with accurate, real time information as the incident is occurring so they can make informed decisions without having to be within the State Emergency Operations Center (SEOC).

When different stakeholders share information with the SEOC, that information can be made available

to WebEOC users. Communities may utilize WebEOC for a special event or critical incident that is occurring within their area. It is also important to keep in mind that if a critical incident is occurring, HSEM should be contacted and made aware of the situation.

If there is a power outage, WebEOC has multiple backups. As long as internet connectivity is available to the servers, WebEOC should be accessible during a disaster. WebEOC is also mobile friendly which allows it to be used when traditional internet capabilities are not available.

HSEM is always looking to expand the use of WebEOC. If there is a problem that you think WebEOC could solve, please contact HSEM. Classes are offered monthly at the State EOC and can also be brought into the field and taught at a location closer to you thus allowing more personnel to participate. The fiscal year 2016 Hazard Mitigation Assistance Program application period opened Tuesday, March 15, 2016. The program consists of the Pre-Disaster Mitigation (PDM) Program and the Flood Mitigation Assistance Program.

Allowable activities in support of the Pre-Disaster Mitigation Program objectives are:

- Local hazard mitigation plans
- Cost effective and sustainable hazard mitigation projects such as: climate resilient mitigation activities, including aquifer storage and recovery, floodplain and stream restoration, culvert upgrades and flood diversion and storage

Allowable activities in support of the Flood Mitigation Assistance Program objectives are:

- Flood hazard mitigation planning
- Cost effective and sustainable hazard mitigation projects such as: property acquisition and demolition, structure elevation and mitigation reconstruction



TRI-MEWeb To Replace Paper Reports

Online reporting for the Toxic Release Inventory (TRI) will soon be available. TRI-MEWeb, the online reporting system, uses the Environmental Protection Agency's (EPA) Central Data Exchange and eliminates the need for New Hampshire facilities to send paper copies of their Form R to the State after submitting it electronically to the EPA.

The TRI-MEWeb system works by simultaneously transmitting reports to participating states via the National Environmental Information Exchange Net-

work (i.e., Exchange Network). Reports filed using TRI-MEWeb represent a facility's official submission to both the EPA and the State. Once the reports are submitted, the State will have access to the data through a password-protected account.

New Hampshire is among 49 other states to have joined the online electronic reporting system.

Tier II Reporting

The 2015 Tier II reporting deadline has passed and, to date, HSEM has received 1,481 reports. Tier II reports were developed by the U.S. Environmental Protection Agency (EPA) to help facilities provide state and local officials and the public with information on

the general hazard types and locations of hazardous chemicals present at facilities during the previous calendar year.

Funding for Local Exercises Available

The State Homeland Security Exercise and Evaluation Program (HSEEP) provides funding to local emergency management officials for the coordination and execution of workshops, table-top exercises and functional exercises. HSEEP Grants are currently available.

During the first quarter of 2016, HSEEP funded table-top exercises were held at the University of New Hampshire, in the towns of Acworth, Brentwood and Sandwich and with the Epping and Winnisquam School Administrative Units. These exercises reviewed response components of Emergency Operations Plans pertaining to active shooters, active threat and structural damage from a severe weather incident.

HSEEP also funded training and exercise planning workshops hosted by the Central New Hampshire Hazmat Team, Southeastern New Hampshire Hazmat Team and the New Hampshire Tactical Officers Association. These workshops covered topics including preparations for a radiation deployment exercise, guides to standard operating procedures development and discussions of training and exercise plans.

Updated Overtime & Backfill Form for Exercise Reimbursement

An updated overtime and backfill form must be completed in order to receive reimbursement for exercise and training overtime and backfill that has been approved for grant reimbursement by HSEM or the New Hampshire Fire Academy. The updated form is identified on the top with "Effective for Eligible Events 10/1/14 or later".

Using the updated form is the quickest means of receiving reimbursement for approved exercises and

trainings and will help avoid delays caused by using the old form. The new form has been included in all reimbursement packets from both HSEM and the NH Fire Academy.
