

#### **Public Assistance for January 2015 Blizzard Continues**

The Public Assistance reimbursement process for local communities, schools, state agencies and eligible private non-profits for the January 2015 Snow Storm, disaster DR-4209, continues. As of January 2016, 159 project worksheets have been processed from 129 applicants resulting in the Federal Emergency Management Agency (FEMA) obligating \$4,740,668 in reimbursement for damage and clean up costs caused by the storm. The total cost for this event may exceed \$5 million. ### **Deadline for Tier2 Submit Approaching**

Tier2 reports were developed by the Environmental Protection Agency (EPA) to help facilities provide State and local officials and the public with information on the general hazard types and locations of hazardous chemicals present at facilities during the previous calendar year. Tier2 reports are due on March 1, 2016. The reports can be submitted electronically

#### **\$721,529 Received for Hazard Mitigation Grants**

The Hazard Mitigation Grant Program has \$721,529 available to local communities, state agencies and eligible non-profits for mitigation projects that will reduce potential risks created by future disasters and lessen the need for future federal funding assistance. The grant funds are provided as part of FEMA's response to the January Snow Storm disaster declaration, DR-4209.

To date, seven applications have been submitted to the Federal Emergency Management Agency (FEMA) for review, and an additional eight applications will be submitted to FEMA in February.

#### FEMA Funding Contingent on Having an Approved Hazard Mitigation Plan

Communities seeking federal funding from the Federal Emergency Management Agency (FEMA) must have a FEMA approved local Hazard Mitigation Plan. The Hazard Mitigation Plan provides a blueprint of the community's vulnerabilities and maps the community's course of action on how to reduce or eliminate emergencies and the impact of disasters affecting their community. About 90 percent of New Hampshire communities have a FEMA approved hazard mitigation plan. ### **Funding Available Through Emergency Management Performance Grant**

The Emergency Management Performance Grant Program (EMPG) assists local community, state and county agencies, dispatch centers, water precincts, village districts and critical non-profit entities in preparing for all hazards. Grant funds are available to help fund preparedness items such as generators, communications equipment and emergency plans. The EMPG Program is an open enrollment grant allowing applicants to apply for grant funds at any time throughout the year. Current high priority projects for planning initiatives include developing current Local Emergency Operations Plan s (LEOPs), All-Hazards Mitigation Plans, and Continuity of Operations Plans (COOP)/Continuity of Government Plans (COG).

In 2015, HSEM released a new LEOP template

that mirrors the state's recently updated EOP. To date, 20 communities, through EMPG funding, have utilized the template with great success. Current high priority projects for equipment includes radios for schools, radio repeaters for school buildings, and generators for primary shelters, EOCs, sewer/water facilities, and critical communication structures.

### **School Emergency Operations Plan Workshop Available**

The first of five Developing High Quality Emergency Operations Plans for School workshops was conducted in January. Thirty-four participants from a variety of School Administrative Units (SAU) attended. This workshop instructed participants in how to develop a high quality Emergency Operations Plan (EOP) for their school district. Participants included SAUs from the City of Manchester, the North Country and southern New Hampshire. This workshop was funded through a grant award from the U.S. Department of Education and in partnership with funding through the Emergency Management Performance Grant (EMPG) and with support from the Department of Education.

### **HSEM Offers Free School Physical Security Assessments**

The Division of Homeland Security and Emergency Management School Emergency Readiness Program offers free physical security assessments of Kindergarten through Grade 12 schools across the State. There are 476 public schools and 151 private, charter and pre-schools throughout the state of New Hampshire. As of January 2016, 40 percent of all public and private schools had completed an assessment. That leaves an additional 60 percent of schools remaining. HSEM also offers support for classroom instruction in the National Incident Management System, the Incident Command System, and Emergency Operations Plan development.

## **Rochester Reception Center Exercise**

Homeland Security and Emergency Management along with the Department of Health and Human Services Emergency Services Unit and the Division of Public Health Services conducted the first Combined Functional Exercise (CFE) for Seabrook Station Reception Centers in January. As part of this Seabrook Station Exercise Cycle, the Rochester Reception Center located at the Rochester Middle School will be evaluated by FEMA. HSEM personnel served as controllers and assisted with instruments and supplies, male and female decontamination, secondary monitoring, and vehicle monitoring among others.

The second CFE for the Reception Center will be held on February 22, 2016 and the FEMA evaluated exercise will be held on March 23, 2016.

## An Alert Public is Critical to Keeping Our Nation Safe

The U.S. Department of Homeland Security's "If You See Something, Say Something<sup>™</sup>" (S4) campaign is a simple and effective program that raises public awareness of indicators of terrorism and terrorism-related crime and to emphasize the importance of reporting suspicious activity to the proper local law enforcement authorities.

An important part of the S4 campaign is the Nationwide Suspicious Activity Reports Initiative and the critical role the public performs in reporting suspicious activity. Suspicious activities are behaviors and indicators that, when viewed in the totality of the circumstances, may reasonably indicate terrorism-related criminal activity. Suspicious activity reporting is focused on behaviors that would arouse suspicion in a reasonable person, including any of the following:

- Eliciting Information
- Testing of Security
- Recruiting
- Photography/Videotaping

- Observations/Surveillance
- Materials Acquisition/Storage
- Acquisition of Expertise
- Weapons Discovery
- Breach/Attempted Intrusion
- Misrepresentation
- Sabotage/Tampering/Vandalism
- Cyberattack
- Expressed or Implied threat

First Amendment activities should not be reported as suspicious activity, unless the facts and circumstances supporting the behavior observed is reasonably indicative of criminal activity associated with terrorism, including evidence of pre-operational planning related to terrorism. Race, ethnicity, national origin, or religious affiliation should not be considered as factors that create suspicion.

# **Online Suspicious Activity Report (SAR) Training Offered**

The Nationwide Suspicious Activity Report (SAR) Initiative (NSI) training is designed to increase the effectiveness of state, local, and tribal law enforcement and public safety professionals and other frontline partners in identifying, reporting, evaluating, and sharing pre-incident terrorism indicators to prevent acts of terrorism. To increase the effectiveness of this multifaceted approach, the NSI has developed training programs for frontline officers and hometown security partners regarding documented and verified behaviors and indicators that, when viewed in the totality of circumstances, may indicate terrorism-related criminal activity.

Both the SAR Line Officer Training and each sector-specific SAR Hometown Security Partners Training discuss how to report identified suspicious activity to the proper authorities while maintaining the protection of citizens' privacy, civil rights, and civil liberties.
