- 20 1. The above Respondents were properly served with the Order in this  
 21 matter on or about May 9, 2011.
- 22 2. Since the issuance of the Order, Respondent LeadPoint, Inc. d/b/a  
 23 Secure Rights and d/b/a Amerivalue entered into a Consent Order with  
 24 the Petitioner on December 30, 2011 and its Mortgage Broker license  
 25 was simultaneously issued.

1 3. Based on the above factors and as a sign of good faith and  
2 administrative efficiency, the Petitioner now wishes to dismiss the  
3 Remaining Respondents as the matter has now been resolved.

4 WHEREFORE, Petitioner respectfully prays

5 A. The Commissioner dismiss the Remaining Respondents in the Order to  
6 Show Cause and Cease and Desist in this case; and
