15 MOTION TO DISMISS

16 Now comes Maryam Torben Desfosses, on behalf of New Hampshire Banking
17 Department ("Department") in the above captioned matter, and moves to dismiss
18 Respondents Linda Lewis, Richard Medlock, Joseph Morovits from the Order,
19 and states as follows:

- 20 1. The Commissioner of the New Hampshire Banking Department
 21 ("Department") issued an Order to Show Cause and Cease and Desist
 22 ("Order") against Respondents Express Consolidation, Inc., Randall L.
 23 Leshin, P.A. (d/b/a RLL), Randall L. Leshin, Esq., Linda Lewis,
 24 Richard Medlock, [REDACTED] Joseph Morovits, [REDACTED] and
 25 [REDACTED] on December 23, 2011 via U.S. Certified Mail Return

1 Receipt requested.

2 2. The Department attempted proper service and delivery of the Order to
3 all above-named Respondents.

4 3. On February 1, 2012, Express Consolidation, Inc., Randall L. Leshin,
5 P.A. (d/b/a RLL), and Randall L. Leshin, Esq. filed a Motion to
6 Dismiss Notice Order Show Cause and Cease and Desist or in the
7 Alternative Request for Hearing ("Motion to Dismiss").

8 4. The Motion to Dismiss states "Linda Lewis, Richard Medlock, Joseph
9 Morovits . . . do not reside at the address where the Order to Show
10 Cause was mailed. They have NOT received the notice and have never
11 been served."

12 5. After further review of the facts and circumstances of this matter,
13 the Department deems it appropriate to dismiss the Order as to
14 Respondents Linda Lewis, Richard Medlock, Joseph Morovits.

15 WHEREFORE, Department respectfully requests

16 A. The Presiding Officer Dismiss Respondents Linda Lewis, Richard
17 Medlock, Joseph Morovits from the Order in this matter; and

18 B. Grant such further relief as is just and in the public interest.
