9 Default Judgment

10 The Commissioner of the New Hampshire Banking Department  
 11 ("Department") issued an Order to Show Cause ("Order") against the  
 12 Respondents Accountable Mortgage.com ("Respondent Accountable Mortgage") and  
 13 Kevin Leon Martin ("Respondent Martin") on December 31, 2008 via U.S.  
 14 Certified Mail Return Receipt requested. The Order was returned to the  
 15 Department as "Not Deliverable, Unable to Forward."

16 The Commissioner accepted service of the Order on behalf of the above  
 17 named Respondents on March 3, 2009. The Respondents had thirty (30) days  
 18 from March 3, 2009 to request a hearing or reach a settlement with the  
 19 Department. The Respondents failed to request a hearing or reach a  
 20 settlement with the Department on or before April 2, 2009 (which is thirty  
 21 days from March 3, 2009) as required to avoid Default.

22 It is hereby ORDERED, that:

- 23 1. By operation of law, a default judgment was entered against  
 24 Respondents on April 3, 2009;  
 25 2. The allegations contained in the Order hereby deemed true;

- 1 3. Respondent Accountable Mortgage shall immediately pay to the  
2 Department an administrative fine in the amount of \$15,000.00;
- 3 4. Respondent Martin shall immediately pay to the Department an  
4 administrative fine in the amount of \$17,500.00;
- 5 5. Respondents shall immediately pay to the Department the outstanding  
6 examination invoice totaling \$785.00;
- 7 6. Respondents shall immediately pay to the Department the accrued  
8 statutory sum of \$3,450.00 for the late filing of and/or failure to  
9 file examination materials;
- 10 7. Respondents shall immediately pay to the Department the remaining  
11 unpaid portion of the statutory sum of \$150.00 for the late filing of  
12 the financial statement;
- 13 8. Each of the above named Respondents shall be jointly and severally  
14 liable for the amounts in Paragraph 3 through 7 above; and
- 15 9. Respondent Accountable Mortgage's license is hereby revoked.
