11 Default Judgment

12 The Commissioner of the New Hampshire Banking Department
 13 ("Department") issued an Order to Show Cause against Respondent Mortgage
 14 Resource Professionals Inc (d/b/a Mortgage Resource Professionals of New
 15 England) ("Respondent Mortgage Resource Professionals"), Respondent Lynn
 16 Claire Gaulin ("Respondent L.C. Gaulin") and Respondent Michael D. Gaulin
 17 ("Respondent M.D. Gaulin") (collectively, "Respondents") on April 30, 2010
 18 via U.S. Certified Mail Return Receipt requested. The Order to Show Cause
 19 was returned to the Department on May 12, 2010 and the Commissioner took
 20 service on June 17, 2010. The Respondents had thirty (30) days from June
 21 17, 2010 to request a hearing or reach a settlement with the Department.
 22 The Respondents failed to request a hearing or reach a settlement with the
 23 Department on or before July 17, 2010 (which is thirty days from June 17,
 24 2010) as required to avoid Default.

1 It is hereby ORDERED, that:

- 2 1. By operation of law, a default judgment was entered against
3 Respondents on July 18, 2010;
- 4 2. The allegations contained in the April 30, 2010 Order to Show Cause
5 are hereby deemed true;
- 6 3. Respondent Mortgage Resource Professionals shall immediately pay to
7 the Department an administrative fine for one (1) violation of RSA
8 Chapter 397-A in the amount of \$2,500.00;
- 9 4. Respondent L.C. Gaulin shall immediately pay to the Department an
10 administrative fine for two (2) violations of RSA Chapter 397-A in the
11 amount of \$5,000.00;
- 12 5. Respondent M.D. Gaulin shall immediately pay to the Department an
13 administrative fine for two (2) violations of RSA Chapter 397-A in the
14 amount of \$5,000.00;
- 15 6. Respondent Mortgage Resource Professionals shall immediately pay to
16 the Department the outstanding exam invoice totaling \$500.00;
- 17 7. Each of the above named Respondents shall be jointly and severally
18 liable; and
- 19 8. Respondent Mortgage Resource Professional's license is hereby revoked.
