### Welcome to OS/OW Online Permitting!

Our **NHDOT Permitting** Web site will streamline your Oversize/Overweight vehicle permitting process. If you are moving a vehicle and/or a non-divisible load on New Hampshire state maintained highways and you exceed the legal requirements, you can now apply for your permits online, 24 hours a day, 7 days a week.

Permits will be processed in the order they are received, by date and time requested, Monday - Friday between the hours of 8:00 AM - 4:00 PM EST/EDT, except holidays.

NHDOT Permits is the new oversize/overweight (OS/OW) permitting system for the State of New Hampshire. Soft Launch is currently scheduled for January 08, 2019 and Go Live is scheduled for February 05, 2019. Changes to the Soft Launch and Go Live dates, if any, will be provided.

During Soft Launch, limited carriers and Permit Services will be invited by NHDOT to migrate to the new system. As Soft Launch progresses, additional carriers and permit services will be invited to migrate to the new system. Soft Launch will include on-going debugging and resolution of any issues.

To access NHDOT Permits, there will be a new URL that will be provided with the Soft Launch invitations. The new URL will also be provided to all carriers and Permit Services shortly prior to Go Live. After Go Live, all carriers and Permit Services will be required to migrate to the new system and all OS/OW permitting applications will need to be processed using the new system. The old OverHaul system will not be accessible for obtaining OS/OW permits after Go Live and those attempting to access OverHaul at the old URL will be automatically diverted to the new URL.

NHDOT Permits will streamline the Oversize/Overweight vehicle permitting process. If you are moving a vehicle and/or load that exceed legal dimensions or weight, you can apply for Oversize/Overweight permits online 24 hours a day, 7 days a week, 365 days a year. Some permits will be auto-issued by the permitting system depending on dimensions, weight, routes, and current restrictions.

### New features of NHDOT Permits:

- **Automated Routing.** This feature uses a map interface that will select a route based on origin and destination points, load dimensions, weight, current restrictions, and bridge Live Load Analysis (LLA) for all overweight loads.
- **Auto-Issue.** Permits for loads up to 149,999 pounds that do not exceed 15 feet in width, 110 feet in length, or 13 feet 6 inches in height may be eligible for auto issuance provided.
- **Restriction Manager.** All construction, maintenance, parade, and annual spring restrictions on NHDOT maintained roads are managed within the Restriction Manager of the new permitting system and will be used with the automated routing feature.
- **Documents/Forms.** The new permitting system has the capability to download and upload any applicable permitting forms.
  - Download Route Survey Forms
  - Upload completed Route Survey Forms. Approved Route Surveys can be reused for applicable permit applications that meet the same load and route criteria up to 30 days after the Route Survey approval date.
  - Upload Independent Engineering Reports and Traffic Control Plans when required
- **Electronic Permit PDF.** Issued permits will be delivered to you based on the delivery method selected during the permit application process. The checklist and guidance documents will be provided with each issued permit.
- **Escrow.** Carriers and Permit Services will have the ability to pay for permits using a prefunded account. Escrow accounts must be funded by check and mailed to the address provided on the Escrow Deposit Submittal Form available in NHDOT Permits.
