THIS PROJECT IS TASKED WITH FINDING A SITE FOR 19.9 AC-FT OF COMPENSATORY FLOODPLAIN MITIGATION FOR PREVIOUS ROADWAY CONSTRUCTION IMPACTS WITHIN THE ASHUELOT RIVER WATERSHED IN KEENE ASSOCIATED WITH IMPROVEMENTS TO ROUTES 9, 10, 12 AND 101. THIS MEETING WILL UPDATE THE CITY AND PUBLIC ON THE ALTERNATIVES EVALUATED FOR THE PROJECT AND PRESENT THE PREFERRED ALTERNATIVE SITE CHOSEN BY NHDOT IN CONSULTATION WITH THE TECHNICAL ADVISORY GROUP.
