

'DRIVE SOBER OR GET PULLED OVER' CAMPAIGN LAUNCHES AHEAD OF LABOR DAY WEEKEND

CONCORD, New Hampshire – Beginning tomorrow and continuing through the Labor Day holiday period, nearly 100 New Hampshire law enforcement agencies will participate in the *Drive Sober or Get Pulled Over* campaign, a nationwide high-visibility impaired driving enforcement mobilization. During the effort, funded through grants issued by the New Hampshire Office of Highway Safety (NHOHS), agencies will be working together to find and arrest drunk drivers. Residents and visitors should anticipate seeing an increased presence of state, county, and local law enforcement officers on roadways throughout the state.

From 2019 to 2022, a total of 151 people were killed in crashes involving alcohol-impaired drivers statewide, according to data maintained by the New Hampshire Department of Safety's Division of Motor Vehicles. Since 2020, the number of people killed in alcohol-related crashes during Labor Day weekend - and throughout the rest of the year - has increased, while the total number of crashes involving impaired drivers has slowed.

"This campaign helps us to get the message out that drunk driving is illegal and it unnecessarily takes lives," said New Hampshire State Police Captain Chris Vetter, who serves as commander of the Office of Highway Safety. "We are hopeful it will push drivers to think twice and avoid a DUI arrest plus potentially spending a night in jail, losing their job – or worse."
