CONSENT ORDER

This Consent Order is made between the New Hampshire Insurance Department (“NHID”) and Douglas A. Bevins (“Respondent”), the terms of which are as follows:

1. The Respondent is a licensed New Hampshire resident insurance producer. The Respondent is licensed to sell Life, Accident and Health insurance products.
2. By an Order to Show Cause and Notice of Hearing dated October 30, 2012, the NHID instituted an administrative proceeding against the Respondent alleging violations of RSA 402-J:12, I (a) and (h). On November 30, 2012, the NHID issued an Amended Order to Show Cause which alleged the Respondent violated RSA 402-J:12, I (i) in addition to the violations of RSA 402-J:12, I (a) and (h) alleged in the original Order to Show Cause.
3. An adjudicative hearing on the merits was conducted at the offices of the NHID on December 5, 2012. The Hearing Officer was James Fox, Esquire. The Respondent was represented by counsel at the hearing.
4. On February 14, 2013, the Hearing Officer, pursuant to Ins 204.26 (a) (1), submitted to the Commissioner a Proposed Decision and Order. The Proposed Decision and Order determined that the NHID had proven that the Respondent violated RSA 402-J:12, I (a), (h) and (i), and ordered revocation of the Respondent’s New Hampshire insurance producer’s license and imposition of a \$7,500.00 administrative fine.

5. The Respondent does not contest the factual findings of the Hearing Officer as set forth in the Proposed Decision and Order concerning RSA 402-J:12, I (a), (h) and (i), and wishes to resolve this matter rather than litigate further. The Respondent therefore agrees to this Consent Order

WHEREFORE, upon consent of the NHID and the Respondent, it is hereby ordered that:

- A. The foregoing recitals are adopted, incorporated and made a part of this Consent Order.
- B. Pursuant to the NHID's authority under RSA 402-J:12, I, and RSA 400-A:15, III, the Respondent's resident New Hampshire insurance producer's license is revoked. The revocation of the Respondent's resident New Hampshire insurance producer's license shall be effective April 15, 2013.
- C. The NHID waives any administrative fine against the Respondent, including, but not limited to, the \$7,500.00 fine referenced in the Proposed Decision and Order.
- D. The Respondent waives any right he may have had to seek rehearing or reconsideration of the Proposed Decision and Order. The Respondent further waives any right he may have had to appeal to the New Hampshire Supreme Court any order or decision issued by the NHID in the matter of *In Re: Douglas A. Bevins*, Docket No. INS No. 12-035-EP.
- E. By entering into this Consent Order, the NHID and the Respondent intend to resolve all issues relating to the matter of *In Re: Douglas A. Bevins*, Docket No. INS No. 12-035-EP. This Consent Order shall be deemed a full and final resolution, and is in lieu of any other action that could have been brought by the NHID relating to matters disclosed herein.
- F. The Respondent acknowledges that prior to executing this Consent Order, he consulted with counsel regarding the provisions of this Consent Order.

G. This Consent Order shall be fully enforceable in any Superior Court in the State of New Hampshire, and any action to enforce this Consent Order shall be governed by the laws of the State of New Hampshire.

It is **SO ORDERED**.


