

ORDER APPROVING CLAIM, RELEASE AGREEMENT,  
AND DISTRIBUTION OF ASSETS

On consideration of the motion of Roger A. Sevigny, Insurance Commissioner of the State of New Hampshire, as Liquidator ("Liquidator") of Patriot Health Insurance Company, Inc. ("Patriot"), for approval of claim, release agreement, and distribution of assets ("Motion") and the supporting affidavit of Peter A. Bengelsdorf, it is hereby found and ORDERED as follows:

1. The Liquidator's Motion is GRANTED.
2. The administration costs claim of the New Hampshire Life and Health Insurance Guaranty Association ("NHLHIGA") is APPROVED as a Class I claim in the aggregate amount of \$175,893 (inclusive of previously allowed amounts).
3. The Release Agreement entered into by the Liquidator with the United States is APPROVED.
4. The Liquidator is AUTHORIZED to distribute Patriot's assets (after payment of NHLHIGA's claim for administration costs and establishment of a reserve not to exceed \$33,000 for the Liquidator's administration costs) to claimants with allowed Class II claims in the Patriot estate previously approved by the Court.
