Department Updates

<u>Insurance</u>— Ms. MacFadden stated the NCCI workers' compensation rate was approved. The Voluntary Loss Costs is -9%. All other rates will go into effect January 1, 2017. In the premium report New Hampshire fell from 12 to 17; number 1 is California; Massachusetts is number 44 and Main is number 14.

Otherwise Ms. MacFadden stated business is as usual.

<u>Labor</u>— Mr. Ogden state business is as usual at the Department and the hearing on § 24-A did not go forward.

<u>Legislature</u>—Representative Seaworth stated that the House Labor Committee met to discuss interim bills. There were two for workers compensation. The bill to exempt farms was unanimously decided to not move forward.

The Definition of Employee is going to continue to be worked on.

Ms. MacFadden stated that on SB409 – soft tissue – their recommending to legislation to expand soft tissue to include internal organs and expand permanent impairment awards. Representative Seaworth stated he would coordinate on how to go about this bill.
