

March 14, 2013 CLARIFICATIONS AND AMENDMENTS:

AMENDMENT:

Pursuant to Section 1.5.3, Page 7 of the Transportation Services RFP, the NHSLC has the authority to amend the RFP at any time and at its sole discretion.

In Section 1.3, Page 6, the NHSLC stated that official responses, official answers, and/or written information issued in writing by the Issuing Officer shall be the same as amendments.

The NHSLC hereby amends the RFP as follows:

1. Section 1.4, Page 6 in the last paragraph, fifth sentence, is amended to read as follows:

The NHSLC's final response to Vendor inquiries and any requested changes to terms and conditions raised during the Vendor Inquiry Period will be posted on the Commission website.

2. Appendix C, Page 29, 5th paragraph,

Co-Mingling Occurs at the private warehouse.

The question raised about co-mingling, uses the term "linehaul" with which we are not familiar. We believe the following explanation answers the question. The NHSLC retail stores submit replenishment orders to resupply Product. Cases to fill replenishment orders from the stores can be housed in the Concord warehouse or the private warehouse now in Nashua and as of January 2014, in Bow. When a certain replenishment order is placed, co-mingling consists of transporting cases housed in Concord to the private warehouse where they are staged with cases from the private warehouse.

After the Concord warehouse ceases to store bailment product, in mid-January 2014, it will be used to store NH-manufactured product and special non-bailment buy-ins. These products will also require co-mingling at the Bow warehouse but with far less case volume.

3. Appendix H is amended so that the Title of the Appendix is changed from

"CONTAINS THE NHSLC's LOW AND HIGH DELIVERY SCHEDULES TO NHSLC RETAIL STORES"

to

“Store Delivery Schedule Frequency”

The reason for this amendment is to clarify that the basic schedule remains the same. The number of cases delivered to each store may change depending on the demand, but the basic delivery schedule remains fairly constant. Please note that the Commission reserves the right to change this schedule when necessary.

Appendix H (below) has been updated to change the schedule for Store 1 and to add the schedule for Store 3.
