REASONABLE AND PRUDENT PERSON WOULD KNOW IS INTOXICATED; THE COMMISSION ORDERS THE PARTIES TO SUBMIT, WITHIN TEN CALENDAR DAYS FROM THE DATE OF THE DECISION AND ORDER, RECOMMENDED PENALTIES AS ASSOCIATED WITH THE CONCLUSION OF LAW; ONCE RECEIVED AND CONSIDERED, A FINAL DISPOSITION AND ORDER SHALL BE ISSUED.
