COMMISSIONER MILLIGAN MOVED TO TABLE THIS ITEM; CHAIRMAN MOLLICA SECONDED THE MOTION; THE MOTION PASSED; CHIEF EDWARDS OF THE DIVISION OF ENFORCEMENT STATED THE PROSPECTIVE LICENSEE LACKS THE PROPER ALIEN STATUS TO HOLD A LIQUOR LICENSE; THE PROSPECTIVE LICENSEE, SANDEEP ARORA, VERBALLY EXPRESSED HIS NEED FOR A LIQUOR LICENSE, THAT HE FELT HE WAS QUALIFIED TO HOLD A LICENSE UNDER THE LAW, THAT THE FORMS COMPLETED TO OBTAIN THE LICENSE WERE UNCLEAR RELATIVE TO ALIEN STATUS, AND THE DAMAGES HE WOULD SUFFER IF NOT GRANTED A LICENSE; THE COMMISSION INSTRUCTED CHIEF EDWARDS TO SEEK A LEGAL OPINION FROM THE ATTORNEY GENERAL'S OFFICE; CHIEF EDWARDS AND THE PROSPECTIVE LICENSEE SHALL SUBMIT TO THE COMMISSION A WRITTEN ARGUMENT TO SUPPORT THEIR POSITION.

THE ATTORNEY GENERAL'S OFFICE INFORMED THE DIVISION OF ENFORCEMENT THAT THE PROSPECTIVE LICENSEE'S ALIEN STATUS DOES NOT BAR HIM FROM OBTAINING A LIQUOR LICENSE.

COMMISSION MILLIGAN MOVED FOR THE LICENSEE TO OPERATE UNDER A TEMPORARY LIQUOR LICENSE; THIS ITEM WILL BE VOTED UPON WHEN THE LICENSEE APPEARS BEFORE THE COMMISSION; CHAIRMAN MOLLICA SECONDED; THE MOTION PASSED. THE LICENSEE WILL COME BEFORE THE COMMISSION ON MAY 8, 2013.

COMMISSIONER MILLIGAN MOVED TO TAKE THIS ITEM OFF THE TABLE AND TO APPROVE THE LIQUOR LICENSE; CHAIRMAN MOLLICA SECONDED THE MOTIONS; THE MOTIONS PASSED.

LISA SOIETT APPEARED BEFORE THE COMMISSION WITH LICENSEE, PAUL SUMBLIARIS AND PAUL PIRAINO TO CHANGE THE RESTAURANT LICENSE TO A BREW PUB LICENSE; THE LICENSE QUESTIONED WHETHER THE LICENSEE COULD SELL BEER IN HIS ESTABLISHMENT THAT HAD BEEN MANUFACTURED BY OTHER BEER PRODUCERS; CHIEF EDWARDS OF THE DIVISION OF ENFORCEMENT STATED THE LICENSEE COULD ONLY SELL ON HIS PROPERTY BEER THAT HE PRODUCED; CHIEF EDWARDS AND THE LICENSEE WERE INSTRUCTED TO SUBMIT A WITTEN ARGUMENT SUPPORTING THEIR RESPECTIVE POSITIONS. THE DIVISION OF ENFORCEMENT ARGUES THAT THE LICENSEE INTENDS TO BREW BEER AND SELL IT UNDER BOTH THE COMBINATION AND BREW PUB LICENSES BUT WOULD ALSO LIKE TO SELL BEER PRODUCTS PRODUCED BY OTHER MANUFACTURERS WHICH IS NOT ALLOWED PURSUANT RSA 179:11; THE COMMISSION IS AWAITING A WRITTEN ARGUMENT FROM THE LICENSEE.
