**THE COMMISSIONERS REQUESTED THAT LICENSEE JAMES UDICE APPEAR BEFORE THEM TODAY; DEPUTY COMMISSIONER MILLIGAN ADDRESSED MR. UDICE DIRECTLY; HE STRESSED THE IMPORTANCE OF A LICENSEE BEING COMPLIANT WITH THE LAWS THAT GOVERN HIS LIQUOR LICENSE; THE ENFORCEMENT DIVISION IS AVAILABLE TO HELP HIM IN THIS REGARD; THEY CAN PROVIDE TRAINING FOR HIS EMPLOYEES AND STOP BY HIS ESTABLISHMENT WHEN HE IS NOT THERE IF HE WOULD LIKE; THE COMMISSION UNDERSTANDS THAT LICENSEES CANNOT BE AT THEIR BUSINESS ALL THE TIME; THEY VALUE HIM AS A LICENSEE AND WANT HIS BUSINESS TO SUCCEED; HOWEVER, THEY MUST TAKE INTO CONSIDERATION THE SAFETY OF THE TOWN IN WHICH HE DOES BUSINESS AS WELL AS THAT OF SURROUNDING TOWNS; HE SHOULD CALL IF HE NEEDS ANY ASSISTANCE RELATIVE TO HIS LIQUOR LICENSE.**

**MR. UDICE STATED THAT HE UNDERSTANDS THE COMMISSIONERS' MESSAGE AND THANKED THEM FOR THEIR HELP; HIS BUSINESS IS LARGELY FREQUENTED BY REGULAR CUSTOMERS AND IS NOT CONSIDERED A HANG-OUT; HE HAD CONCERNS WITH A PARTICULAR BARTENDER WHO HE NO LONGER EMPLOYS; IT HAS BECOME MORE DIFFICULT TO HIRE GOOD EMPLOYEES; HOWEVER, HE WILL IMPROVE HIS SITUATION AND WILL CALL THE ENFORCEMENT DIVISION IF HE HAS ANY QUESTIONS.**
