Pending cases #18-127-OF and #18-128-OF shall be placed on file for six (6) months from the date of adjudication and shall not cause penalties referenced in this agreement that are suspended or held in abeyance to come forward or be imposed upon the license; and

The licensee agrees to cease all under age 21 events for a period of no less than twelve (12) months from the date of this fully executed agreement; the licensee agrees to cease providing the current bus transportation, or any similar transportation to and/or from a college facility or any location adjacent to a college facility, for the purpose of promoting patronage in, attendance at or admission to this licensed premise; this shall not preclude the licensee from running a special or promotional event with a limousine service directed at adult patrons for a special event and shall not be a regularly occurring feature of the licensee, but rather an optional, occasional promotional event (i.e. limousine service on Valentine's Day, 2019) nor shall this preclude the licensee from procuring transportation for any person who is leaving this licensed premise who is visibly intoxicated, who a reasonable and prudent person would know is intoxicated or who has the appearance of being unfit or unable to safely transport him or herself.
