An administrative fine of \$2,000, eight (8) points shall be assessed to the liquor license, the license to sell alcohol in the cocktail lounge only shall be suspended for six (6) days commencing January 6, 2019 and re-granted on January 12, 2019, no new patrons shall be allowed to enter the premise after 11:30 p.m.; last call shall occur at 12:00 a.m. for ninety (90) days from the date of the fully signed agreement; upon satisfactory review, last call shall be extended to 1:00 a.m.; if any like violations occur during the ninety (90) day period, last call shall occur at 11:00 p.m. for ninety (90) days commencing the date of adjudication of that offense and any incident involving the local police shall be self-reported by the Person-In-Charge to the NH Liquor Commission, Division of Enforcement within twenty-four (24) hours of the event.
