adjudication; these points shall not prohibit renewal of the liquor license so long as at the time of renewal, there are no pending investigations for like violations and/or adjudicated investigations for like violations; the license to sell, serve or consume alcohol shall be suspended for nine (9) days with three (3) days held in abeyance for twelve (12) months pending no like violation commencing January 6, 2020 and re-granted on January 12, 2020 and Randy Kilty and Stacy Day shall attend a Management Training Seminar (MTS) in a classroom within thirty (30) days from the date of the fully executed agreement; for violation of RSA 179:51, an administrative fine of \$250 shall be suspended for twelve (12) months pending no like violation.
