1. The licensee shall remain in compliance with RSA 178:21 - On Premise Beverage and Liquor License -Full Service Restaurant to include:
    - a. Licensee may sell beverages, specialty beverages, and liquor at tables in the approved dining rooms of the restaurant with or without meals when the restaurant kitchen is in operation and meals are being actively promoted and served in that dining room.
    - b. The dining room shall not, however, be used as a substitute for lounge operations.
    - c. At least 50 percent of gross sales shall fall within the category of food. Restaurants with annual food sales of at least \$75,000 shall be exempt from the 50 percent requirement.
    - d. The restaurant shall be open 5 nights a week for evening meals. The restaurant shall be defined as indicated in the diagram included in Attachment A.
  2. The hours of sale in the restaurant shall be 6:00 am -1:00 am.
  3. Effective January 14, 2021 the hours of sale for all other cocktail lounges and approved areas of service will be restricted for a period of 90 days. The hours of sale will be reviewed by the Division of Enforcement, with input from the Division of Public Health Services through the Attorney General's Office, and the Manchester Police Department in 30, 60, and 90 - day increments. The hours of sale will be as follows:
    - a. Effective immediately, for a period of 30 days, the licensee may sell beverages or liquor from 6:00 am - 10:00 pm, 7 days a week.
    - b. Upon satisfactory review of the first 30-day increment, the licensee may sell beverages or liquor from 6:00 am - 11:00 pm, 7 days a week.
    - c. Upon satisfactory review of the previous-60 day increment, the licensee may sell beverages or liquor from 6:00 am - 12:00 am, 7 days a week.
    - d. Upon satisfactory review of the 90-day increment, the licensee may sell beverages or liquor as outlined by RSA 179:17 - Hours of Sale.
  4. All beverages and liquor served on the premises of on-premises licensees shall be consumed no later than 30 minutes after the expiration of the serving hour.
  5. The licensee is required to comply with Emergency Order #52 - Exhibit B guidelines and all applicable Emergency Orders as issued by Governor Christopher Sununu.
  6. Live Entertainment as defined by RSA 175:1, XLVII, and as prohibited in Emergency Order #52 -Exhibit B or any other applicable or new Emergency Orders, shall be prohibited for a period of 90 days throughout the entire premise.
  7. Upon an unsatisfactory review that demonstrates the licensee is not in compliance with all Emergency Order #52 - Exhibit B guidelines and/or any other applicable Emergency Orders, or is in violation of this order, the hours of sale and service of beverages and liquor will return to 9:00 pm immediately throughout the entire premises upon written notification from the Division and will remain in effect until such case is adjudicated.
  8. This settlement constitutes the complete agreement between and among the Parties and supersedes any and all other written or oral communications or agreements related thereto.
  9. This agreement will remain in effect until such time the Emergency Orders expire.
