This agreement resolves all alleged violations encompassed in Administrative Notice of Agency Action No. 6243, dated January 13, 2021 and Case No. 20-615-OF, including the alleged violations set forth in the Case Summary dated January 7, 2021, as modified through January 13, 2021. It is not nor shall it be construed as an admission of guilt, fault or liability by the Licensee as to such alleged violations, all of which the Licensee denies. The Commission agrees that it shall not hereafter take any agency action or enforcement action based, in whole or in part, on any of the violations set out in the said Case Summary alleged to have occurred prior to January 3, 2021 nor use or refer to such alleged violations in any administrative action or proceeding for another alleged violation.

- 1. Effective January 3, 2021 the hours of sale will be restricted for a period of 90 days. The hours of sale will be reviewed by the Division of Enforcement, with input from the Division of Public Health Services through the Attorney General's Office, and the Manchester Police Department in 30, 60, and 90-day increments. The hours of sale will be as follows:
 - a. Effective January 3, 2021, for a period of 30 days the licensee may sell beverages or liquor from 6:00am-11:30p.m., 7 days a week.
 - b. Upon satisfactory review of the first 30-day increment, the licensee may sell beverages or liquor from 6:00am-12:00a.m., 7 days a week.
 - c. Upon satisfactory review of the previous 60-day increment, the licensee may sell beverages or liquor from 6:00am-12:30am., 7 days a week
 - d. Upon satisfactory review of the 90-day increment, the licensee may sell beverages or liquor as outlined by RSA 179:17 Hours of Sale.
- 2. All beverages and liquor served on the premises of on-premises licensees shall be consumed no later than 30 minutes after expiration of the serving hour.
- 3. Upon satisfactory review the by the Division of Enforcement, Attorney General's Office, and Manchester Police Department the hours of sale shall return to those dictated by RSA 179:17 Hours of Sale.
- 4. All beverages and liquor served on the premises shall be consumed no later than 30 minutes after the expiration of the serving hour.
- 5. The licensee shall comply with all the mandatory provisions and will exercise its best efforts to comply with all voluntary recommendations of Emergency Order #52 Exhibit B as it pertains to the Performing Arts Venues guidelines and all applicable Emergency Orders as issued by Governor Christopher Sununu.
- 6. The licensee shall remain in compliance with all provisions of RSA 179:50 Unlawful Purpose.
- 7. The licensee shall remain in compliance with the attached business plan as proposed by the licensee.
- 8. Upon an unsatisfactory review that demonstrates the licensee is not in compliance with Emergency Order #52- Exhibit B Performing Arts Venue Guidelines and/or any other applicable Emergency Orders; or is in violation of this order, the hours of sale and service of beverages and liquor will be reduced to 9:00p.m. immediately throughout the entire premises upon written notification from the Division, and will remain in effect until such case is adjudicated.
