Count 4 - Violation of RSA 179:5, I - Prohibited Sales: it is alleged that on February 29, 2016, Jade Palace, through the actions of its employee(s) and/or agent, did serve alcoholic beverage to a person who was under the age of twenty-one;

Count 5 - Violation of RSA 179:8, I - Statement From Purchaser As To Age: It is alleged that on February 29, 2016, Jade Palace, through the actions of its employee(s) and/or agent, failed to require the purchaser to furnish a motor vehicle driver's license issued by the state of New Hampshire, or a valid driver's license issued by another state, or province of Canada, which bears the date of birth, name, address and picture of the licensee;

Count 6 - Violation of RSA 179:40, II - Substitution of Brand; Refilling Bottles: It is alleged that on March 1, 2016, Jade Palace, through the actions of its employee(s) and/or agent, refilled bottles of legally purchased beverage or liquor; and

Count 7 - Violation of RSA 179:49 - Storage of Surplus Liquor and Beverages: it is alleged that on March 1, 2016, Jade Palace, through the actions of its employee(s) and/or agent, stored beverages or liquor in any building other than that designated in their license.

Dates of violation: 2/29/2016 & 3/1/2016.

Terms of Settlement:

The Commission withdraws Counts 3, 6 and 7.

For the purpose of this Settlement Agreement only, Licensee waives all claims and defenses to allegations made in Counts 1, 2, 4 and 5 (the "Charged Counts") and stipulates to a finding with respect to the violations alleged in Charged Counts. Licensee otherwise denies the allegations made therein.

Licensee shall pay an administrative fine of \$15,000 with respect to the Charged Counts (the "Administrative Fine"). The Administrative Fine shall be paid to the Commission no later than ninety (90) days following approval of this Settlement Agreement.

Licensee shall forthwith surrender Liquor License #1476403.

Licensee as the corporate entity known as "Alan Yang, Inc." shall forthwith dissolve as a body corporate. In furtherance thereof, Licensee shall secure a Certificate of Dissolution and such related documentation as shall evidence dissolution of the corporate entity from the New Hampshire Secretary of State and the New Hampshire Department of Revenue and produce true and accurate copies of such documentation to the Commission as soon as administratively feasible.

The trade name "Jade Palace" as presently held by Licensee shall forthwith be withdrawn by Licensee by appropriate filing with the New Hampshire Secretary of State. Neither Licensee nor any present officer, director, shareholder, successor or assign of Licensee shall hereafter register the said trade name or advertise, use or apply the said trade name in any business enterprise in the State of New Hampshire.

Licensee has disclosed to the Commission its intention to transfer some or all of its assets and liabilities to a newly-created corporate entity known as "Families' Restaurant, Inc.", doing business under the trade name "Red Mango" (the "Successor Entity"). Licensee has also disclosed to the Commission that (i) the majority shareholder and principal of the Successor Entity is Liping Zheng, (ii) Alan Yang ("Mr. Yang") shall not be a shareholder of the Successor Entity, but (iii) shall be an employee of the Successor Entity.

Licensee acknowledges that Mr. Yang shall not be employed by the Successor Entity as a supervisor of employees with respect to sale and dispensation of alcoholic beverages to customers of the Successor Entity.

The Successor Entity has heretofore secured a Liquor License from the Commission, such that it shall operate a substantially similar business to that of Licensee at the same location of the present business operations of Licensee at Stratham, New Hampshire. Consistent with other provisions of this Settlement Agreement, the Successor Entity shall not under any circumstance operate its business under the trade name "Jade Palace".

HEARING REQUESTED BY COUNSEL OF RECORD.  
LICENSEE'S COUNSEL REQUESTED AND WAS GRANTED A CONTINUANCE;  
SETTLEMENT PENDING.  
HEARING WAS HELD ON MAY 31, 2022.  
**DECISION:** "During the conference it was represented that the license was set to expire on June 3, 2022. As such the parties requested a short-form expedited order. On June 1, 2022, the hearings officer was informed by counsel for the licensee the license actually expired on May 31, 2022, and the licensee is unable to operate his business until receipt of a decision and order regarding this issue. Proffer and exhibits were accepted on the record from both parties per their agreement, and all arguments have been due consideration. Due to the agreement of the parties for an expedited order, I will not address the facts leading to my decision as the parties of aware of them and the licensee has stipulated to the alleged violations, some of which are very concerning, as evidenced in the exhibits provided by the Division of Enforcement. I have also reviewed the licensee's exhibits, which addresses the concerns of the Division. A business plan, employee handbook, renovations and proof of every employee receiving training from the Liquor Commission are all commendable.



For the first thirty days of the 90-day temporary license, hours of sale shall be: Sunday-Wednesday-6:00 A.M.-11:00P.M., Thursday, Friday and Saturday-6:00 A.M.-12:00 A.M. If there are no violations during the first 30 days, hours of sale will increase on Thursday, Friday and Saturday to 12:30 A.M. through the remainder of the 90-day temporary licensure, subject to reduction of hours pending a hearing on any alleged violations from the Division of Enforcement. These hours of sale and conditions shall be incorporated into the proposal provided by the Division of Enforcement & Licensing during the hearing.”
