COURSE DESCRIPTIONS:

S-131 Firefighter Type 1 Squad Boss: This class is designed to meet the training needs of the Firefighter Type 1 (FFT1) and/or Incident Commander Type 5 (ICT5). Topics include operational leadership, communications, LCES, and tactical decision-making.

Prerequisites: Students must be qualified as Firefighter Type 2 (FFT2).

S-230 Crew Boss (Blended): This is a classroom course designed to produce student proficiency in the performance of duties associated with the single resource boss position from initial dispatch through demobilization to the home unit. Topics include operational leadership, preparation and mobilization, assignment preparation, risk management, entrapment avoidance, safety and tactics, offline duties, demobilization, and post-incident responsibilities.

Prerequisites: Qualified as Firefighter Type 1 (FFT1).

Successful completion of Intermediate Wildland Fire Behavior (S-290).

Satisfactory completion of online S-230 pre-course work located on The Learning Portal (Create User Training Account) https://wildlandfirelearningportal.net/login/index.php

Engine Boss, S-231: This is a skill course designed to produce student proficiency in the performance of the duties associated with engine boss, single resource (ENGB). Topics include engine and crew capabilities and limitations, information sources, fire size up considerations, tactics, and wildland/urban interface.

Prerequisites: Qualified as Firefighter Type 1 (FFT1) and successful completion of S-230.
