**PREA DATA REVIEW COMPARISON
SURVEY OF SEXUAL VICTIMIZATION**

PREA Standard 115.88 *Data review for corrective action* states, in part; (a) The agency shall review data collected and aggregated pursuant to § 115.87 in order to assess and improve the effectiveness of its sexual abuse prevention, detection, and training. (b) Such report shall include a comparison of the current year's data with those from previous years and shall provide an assessment of the agency's progress in addressing sexual abuse. (c) The agency's report shall be approved by the agency head and made readily available to the public through its Web site.
