Footnotes:

- The top three rows represent the physical population within DOC facilities, NH sentenced and inmates being held for other jurisdictions; and ties to the official count sheet from the last day of the month.
- The next section represents admissions to the facilities during the previous month.
 - New Admissions-New inmates with no previous DOC contact
 - New Admissions (Previous Record)-New inmates with previous DOC contact.
 - Pending PV-residents returned on a parole violation awaiting revocation hearing.
 - 7 Day-Parolees starting a 7 day sanction per the Justice Reinvestment Initiative.
 - Unknown/Incomplete-Parole returns not covered in the previous two categories; primarily used for data cleansing.
 - Other Jurisdiction/Transfers In-Combination of NH sentenced residents returning from other jurisdictions or new residents being housed for other jurisdictions.
- The next section represents releases from all facilities during the previous month.
 - Max Out-Released to FS (Field Services) - Inmates that have served their maximum sentence but may still have obligations to DOC such as restitution.
 - Ending Pending PV-Parole violators returned to parole without revocation.
 - 7 Day-Parolees leaving from a 7 day sanction.
 - 90 Day-Parolees leaving from a 90 day sanction.
 - Parolee- Residents that are leaving the halfway house after being paroled there due to homelessness.
 - 9 month/120%-Inmates released to parole under the mandatory conditions of the Justice Reinvestment Initiative.
 - Unknown/Incomplete-Same as above.
 - Released to Other/Transfer Out - NH sentenced residents being sent to other jurisdictions or residents returning to other jurisdictions after being housed by DOC.
- The fourth section represents the physical population plus NH sentenced residents that are not physically at a DOC facility. The sum represents all of the residents the NH DOC is responsible for.
- The final section represents the total number of NH sentenced residents serving in a DOC facility and in other jurisdictions. The total represents all NH sentenced residents.
