All full-time permanent Captains, Lieutenants, Chief Fire Inspector and Dispatch Supervisor. <u>Excluded</u>: Chief, Deputy Chiefs, Firefighters, Emergency Medical Technicians, Paramedics and Fire Prevention Inspectors.

Further, IT IS ORDERED that the above named Public Employer shall negotiate collectively with the PROFESSIONAL FIRE OFFICERS OF DERRY, INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, LOCAL 3834 with an objective to reaching an agreement with the employee organization on terms and conditions of employment, and shall negotiate collectively with such employee organization in the determination of, and administration of, grievances.
