BACKGROUND

Reference is made to original decision in the Case No. T-0211 in which it was found that the City of Rochester and the School District had failed to pay certain teachers in accordance with the contract between the Rochester Education Association, NHEA/NEA and the City of Rochester; further reference is made to subsequent decisions of this Board and N. H. Supreme Court decision 7710 and 78-016.

In accordance with this decision, PELRB met with representatives of the City and NHEA on May 11, 1979 in Rochester for the purpose of establishing monies due certain teachers and again in Concord on May 22, 1979. These meetings resulted in both parties, the REA/NHEA and the City of Rochester, represented by Attorney William Cullimore, agreeing to the list of teachers entitled to back pay and the amounts of money due each teacher involved.

ORDER OF THE BOARD

The City of Rochester is ordered to pay the following amounts due to the individuals listed below who are or were teachers of the Rochester School Department during the school year 75-76, the total amount of payment is \$17,401.27. These monies must be paid to the listed individuals on or before November 1, 1979.

2. The City of Rochester is directed to furnish to the Public Employee Labor Relations Board, no later than November 1, 1979, receipts indicating which individuals have received such payment and a record of payments still outstanding.
